12. Grant Application - Green Streets, Green Jobs, Green Towns

Reference: Concept Design Report

On behalf of the City, the Low Impact Development Center (LID Center) received a grant from the Chesapeake Bay Trust (CBT) in 2014 to undertake a retrofit green street concept design to reconstruct Cherrywood Lane as a green and complete street. Concept design plans were developed for three phases of the project covering the approximately 1.5 mile length of Cherrywood Lane from MD 193 to Edmonston Road. Phase One extends from the CVS Pharmacy parking lot entrance at Beltway Plaza to just before the Greenbelt Metro Drive roundabout. Phase One is currently at 30% design and the next step toward implementation is to produce an engineered design.

Under the Green Streets, Green Jobs, Green Towns Grant Program, the City may apply for up to \$30,000 for development of engineered designs. The estimated cost to complete engineered designs for Phase One of the project is approximately \$320,000. It will be necessary to acquire additional funding to complete engineered designs either through additional grants or utilization of Greenbelt West funds dedicated to Cherrywood Lane improvements.

A match is encouraged but not required for this grant. Staff recommends Council pledge at least \$30,000 cash match for this grant. Council should be prepared to provide additional funding or scale back the scope of the project to proceed through engineering. Staff will continue to seek and identify potential grant sources to supplement engineer design costs. Jessica Bellah, Community Planner, will be present to answer questions.

## 13. Greenbelt Station North Core - Development Agreement

Reference: Draft Development Agreement

The City is currently reviewing an Infrastructure Detailed Site Plan for the North Core development. Under the County's development review guidelines, an approved Stormwater Management Concept Plan (SWM Plan) from the Prince George's County Department of Public Works and Transportation is required for this project. Although Renard Development Company, LLC (Renard Development) has an approved SWM Plan, it will need to be revised in May, 2017 to reflect the current site layout proposed in the Detailed Site Plan.

It is in the City's interest to review and provide comment on the revised SWM Plan. Renard Development has proffered to provide the City review and approval authority over this plan. The appropriate method to record this arrangement is through a Development Agreement between the City and Renard Development.

In December 2013, a Development Agreement between Renard Development Company, LLC and the City was drafted detailing the obligations of both parties and specifying the standards and conditions that will govern development of the North Core property. The 2nd item of the Development Agreement outlines those plans for which the City shall be granted approval authority. Staff proposes that this item be amended to include review and approval authority of SWM Plans. Jessica Bellah, Community Planner, will be present to answer questions.

Staff recommends approval of the Draft Development Agreement. (JB)

# 14. State Legislation

Reference: HB 1374

HB 1374 – State Highway Administration Neighbor Notification Act

This bill would require the State Highway Administration (SHA) to provide notice of any planned construction project. SHA would be required to mail a notice to property owners within a 100 yard radius of the construction area at least two weeks in advance. The bill does not apply to emergency repairs. The Maryland Municipal League Legislative Committee voted to support this legislation with an amendment requiring municipal notification.

It is recommended Council support HB 1374 with an amendment requiring municipal notification. (DEM)
