

REGULAR MEETING OF THE GREENBELT CITY COUNCIL held Monday, May 11, 2009.

Mayor Davis called the meeting to order at 8:02 p.m.

ROLL CALL was answered by Councilmembers Konrad E. Herling, Leta M. Mach, Edward V. J. Putens, Rodney M. Roberts and Mayor Judith F. Davis.

ADMINISTRATIVE REPORTS

Mr. McLaughlin reported he had been notified by the County Department of Public Works and Transportation that the City would receive approximately \$40,000 of street resurfacing work due to Stimulus funds. He also noted the problem with the Donation Drop-Off event on May 9th and said a solution would be in place prior to the next event. Mayor Davis thanked employees of the Public Works Department for their assistance in resolving the problem that day.

Mayor Davis and Mr. Herling commented on the Big Cities Conference in Frederick and the Green Man Festival. Mayor Davis also mentioned the Pet Expo.

Ms. Mach commented on the Springhill Lake Elementary School Get Active Program. She reported that School Board Member Rosalind Johnson had mentioned the County may seek gold LEED certification for the new Greenbelt Middle School. Ms. Mach suggested inviting Dr. William R. Hite, Jr., the new Superintendent of Prince George's County Public Schools, to meet with Council and the Advisory Committee on Education.

LEGISLATION:

An Ordinance to Amend Chapter 16 "Public Safety Offenses and Miscellaneous Provisions" of the
