REGULAR MEETING OF THE GREENBELT CITY COUNCIL held Monday, September 22, 2008.

Mayor Davis called the meeting to order at 8:03 p.m.

ROLL CALL was answered by Councilmembers Konrad E. Herling, Rodney M. Roberts, Edward V. J. Putens and Mayor Judith F. Davis. Councilmember Leta M. Mach had previously advised that she could not attend.

ALSO PRESENT were Jeff Williams, Acting City Manager; Robert Manzi, City Solicitor, and Cindy Murray, City Clerk.

Mayor Davis asked for a moment of silence in memory of resident Karen Ann Wege Zoellner. She then led the pledge of allegiance to the flag.

CONSENT AGENDA: It was moved by Mr. Putens and seconded by Mr. Herling that the consent agenda be approved. The motion passed 4-0.

Bill Orleans, Greenbelt, questioned how the ordinance would be enforced. Mr. Manzi explained municipal infractions would be issued to the parties responsible for the signs.

Justin Okezie stated he supported the ordinance but questioned whether the ordinance would be legally challenged in the future since it only prohibits commercial signs. Mr. Manzi said there was always the possibility of a challenge with any legislation.

State Funding Cuts for Transportation Projects: Mayor Davis read the agenda comments.

Mayor Davis moved that the city join with state and county elected officials protesting the transportation cuts by sending a letter to the state noting how the cuts will affect the community. She also moved that the letter include transit related issues supported by the city such as METRO 's Purple Line. Mr. Putens seconded. The motion passed 4-0.

Mr. Roberts and Mayor Davis suggested the letter be shared with the public by publishing it in the News Review._

<u>MEETINGS</u>: Council reviewed the meeting schedule. At the suggestion of Mr. Roberts following the Greenbelt Middle School Public Forum, Mayor Davis requested a work session be scheduled with the Board of Education regarding the funding, usage and detailed plans for the historic portion of the current school building.

ADJOURNMENT: A motion to adjourn the meeting was made by Mr. Putens and seconded by Mr. Herling. The motion carried 4-0. The Mayor adjourned the regular meeting of Monday, September 22, 2008, at 8:56 pm.
