## RESOLUTION NUMBER 1080

A RESOLUTION TO REPEAL RESOLUTION 1038 AND TO ESTABLISH FEES AND PENALTIES RELATED TO THE ADMINISTRATION AND ENFORCEMENT OF CHAPTER 4 "BUILDINGS AND BUILDING REGULATIONS" OF THE GREENBELT CITY CODE

WHEREAS, Section 4-287 of the City Code provides for the establishment of fees and penalties related to the administration and enforcement of regulations governing the construction, maintenance and occupancy of buildings and properties by resolution of the City Council; and

WHEREAS, Section 4-287 of the City Code establishes that violations of Article III are municipal infractions and subject to fines. NOW, THEREFORE,

BE IT RESOLVED that Resolution 1038 be repealed effective July 1, 2011;

BE IT FURTHER RESOLVED that the following fees and penalties are hereby established for the administration and enforcement of Chapter 4 of the City Code, to be effective July 1, 2011:

## **Inspection fees:**

- (1) <u>Commercial and nonresidential addresses and retail establishments</u> \$285.00 per 1,000 square feet gross floor area, plus \$60.00 per additional 1,000 square feet or portion thereof, to a maximum of \$2,925.00.
- (2) <u>Hotel, motel or tourist facility</u> \$500.00.
- (3) <u>Multifamily rental dwelling unit</u> \$110.00 per unit with no additional charge for common areas of structures containing the dwelling units. Other structures within the multifamily rental complex not used for residency will be treated as a commercial or a nonresidential address and be assessed inspection fees as otherwise set forth in this resolution.
- (4) Single-family, condominium, cooperative, townhouse or other dwelling unit not contained within a multifamily rental community, but otherwise let for occupancy \$150.00 per unit.
- (5) Day care facility \$100.00.
