City Manager's Report Week Ending March 1, 2019

- 1. Included separately is a copy of the GHI letter regarding GHI's NCO Zone Committee work.
- 2. Included separately please find a confidential packet.
- 3. Hat's off to Charise Liggins, Economic Development Coordinator, for a successful Business Coffee with the State Comptroller as speaker. Thanks also to all staff who supported and attended the event. About 70 people RSVP'd.
- 4. As noted via email, the County's Branchville Road Sidewalk Project is underway. As of earlier this week Mr. Sterling reported that the project was expected to be complete next week. Similarly, as shared in another email, the County staff reported that the Sunnyside Avenue Bridge Replacement project is underway and expected to be complete in a year and a half.
- 5. In follow-up to Mayor Jordan's request, Ms. Mary Johnson revised the equal opportunity statistics provided last month to reflect ten years of data.
- 6. Received the Greenbelt East Advisory Coalition (GEAC)'s questions on Wednesday. Staff is compiling a response for next Wednesday's meeting.
- 7. In follow-up to the email this week, staff will place City participation in the mosquito control program on the March 11, 2019 Council agenda. This will allow time to respond to the State request for notification of participation by May 3, 2019. Staff will advertise this effort so that the community is aware.
- 8. In follow-up to Mayor Jordan's request, the County reports that the bikeshare program is still working on logistics. The Greenbelt Metro Station was surveyed by the County's consultant planner who proposed several location options within the metro station. The options were sent to WMATA for approval of a preferred location. County staff explained that the bikeshare stations sites will be conducted under the Transportation Alternative Program (TAP) FY 2019. The County and State are working on an MOU and a grant, anticipating installation by the end of Summer 2020.
- 9. Various departments continue to work on the small cell ordinance related franchise, application and other materials for delivery this Spring. Ms. Palau noted that draft materials have been submitted for review with telecommunications counsel. This will include also include consultation with the City's insurer, LGIT.
- 10. Staff has forwarded information to MML and is working with other managers to understand the potential negative impact on City revenue from proposed legislation regarding business tax credits.
- 11. Review and finalization of Tax Increment Financing (TIF) documents continues. Thank you to David Moran, Jeff Williams, Terri Hruby, and Lannay Tull for their work. Several documents are finalized undergoing processing for the Mayor's signature next week.
- 12. Staff is coordinating an exhibit within the larger Prince George's County booth at the ISCS regional

conference at National Harbor. Ms. Palau has prepared a fantastic backdrop of photos of Greenbelt. As previously reported, the effort is collaboration with the City of Bowie and other municipalities. Public information, planning, and manager's office staff will attend the education and/or exhibit areas next Monday and Tuesday.

- 13. Staff is preparing a state grant application for funding to support City Census 2020 activities. The City will still attempt to partner with other organizations like Metropolitan Washington Council of Governments, Four Cities Coalition, and the County.
- 14. Reporting on the last review of the Sustainable Land Care policy should be to Council soon. One report is slated for Council acceptance in March.
- 15. Interviews for the Recreation Director position are being scheduled.
- 16. Staff received a last minute invite to a State meeting regarding TAMP Financial Review. The invitation noted the City's role in maintaining Cherrywood Lane from MD 201 to Greenbelt Metro. The meeting/teleconference scheduled for today, was cancelled. A document was submitted instead. Staff will review and advise.
- 17. Met with and/or teleconferenced staff and legal counsel to discuss operational, legal, and personnel matters.


