

CARES has partnered with the Prince George's County Summer Food program to provide summer lunches at the Springhill Lake Recreation Center. Participating youth will receive a free lunch 3 days a week. The first day of the program was June 27. Darren Stephenson, who is coordinating the program, served 28 lunches to youth that day. The program aims to serve 30-40 lunches each day.

During the month of June, 12 families on average were seen for counseling at CARES. Fifty-one individuals on average came on a weekly basis among whom sixteen were 18 years of age and younger. The CICs (Crisis Intervention Counselors) saw 13 clients.



ADMINISTRATION:

- Assisted Public Works and the Police Department with the July 4th celebration (both on July 4th and July 5th). Despite the postponement, the drum circle and ice cream vendor were available on July 5th.
- Director visited two of the M-NCPPC sites. Attendance numbers are about the same for the Teen Extreme sites but with Greenbelt Elementary School being the only playground site, their numbers of course have increased.
- Met with Aquatic and Fitness Center staff to review various items.
- Prepared and sent out MML Parks and Recreation Department annual membership information.
- Reviewed end of fiscal year reports in RecTrac.
- Forwarded proof of payment for reimbursement through Program Open Space.

YOUTH CENTER/ SPRINGHILL LAKE/PARK RANGERS/GREENBELT KIDS:

- Summer Camps are now in their third week! We welcomed many new campers to our second session of camp. Kinder Camp embraced a new theme, "Blast Off," with a focus on crafts, stories, and activities with a connection to space and space travel. Our youngest campers also enjoyed yoga, trips to the pool and Ageless Grace. Camp Pine Tree campers enjoyed group games, sports, arts & crafts and a trip to the Greenbelt Theatre to see "The Lego Movie." Camp YOGO traveled to Gaithersburg to enjoy the Water Park and Miniature Golf Course at Bohrer Park, as well as a visit to the Beltsville AMC theatre showing of "The BFG." Creative Kids Campers participated in classes in music, art, drama, dance, writing, ceramics, and worked on their second production of "Summer Circus." Circus Camp welcomed new and returning campers and continued their focus on circus skill development! Camp Encore continued work on this year's production of "A Midsummer Night's Dream." Our campers and camp staff felt the heat this week, so trips to the pool were welcome relief to the hot weather!
- Braden Field Tennis Courts are busy in the afternoons with campers offered an opportunity to stay after camp and learn the sport of tennis. The Tennis After Care Program has been very popular with the campers this session!
- Park Rangers patrolled our parks over the busy July 4th weekend, enforcing park rules and interacting with park visitors.
- Free Summer Fun Runs at Buddy Attick Park began Thursday. Runs are every Thursday evening through 8/26 at 7pm. Registration takes place in the YC parking lot prior to each Thursday event.
- Staff is working on planning Fall programs and publication of the 2016 Fall Activity Guide.

AQUATIC AND FITNESS CENTER:

- Registration started July 2 for residents and pass holders with open registration starting July 5 for session 2 of the children's weekday lessons. At this point, 143 children are enrolled with 33 slots still open.
- Attended weekly meeting with Assistant Director. On Thursday, NBC Channel 4 and the Prince George's County Health Department used the Center as an interview site for a story on inspections on area pools.
- At the request of patrons, began offering a 10 am class on Mondays during the summer. Traditionally, this class has been cancelled all summer while children's lessons are going on. Additionally, held a drop in class on Tuesday and Thursday July 5 and 7 from 10am-10:45am.
- GMST will host a swim-a-thon on Thursday, July 14 from 8pm-10pm in the outdoor pool.

ARTS:

- Creative Kids Camp, Clay at the End of the Day, and the summer stagecraft teen internship program are underway. Quarterly classes running this session include: Family Ceramics; Sew for Charity; Figurative Hand-Building; Paper Resist Techniques for ceramic surface decoration; Ceramics Open Studio; and Levels 1/2 and 3/4 potter's wheel.
- The fall activity guide is being prepared.
- Ongoing tasks include: processing Festival of Lights Juried Art and Craft Fair applications; hiring and training new special event technicians; and developing FY17 programs.

COMMUNITY CENTER:

- A fire drill was conducted.
- Supervisor met with a potential food operation for Kitchen rentals.
- Supervisor met with the Prince George's County Health Department for an inspection with a caterer.
- Supervisor continued to field inquires in regard to food operations rentals for the Commercial Kitchen. There have been 138 inquiries since April 2015. There are currently six caterers who received all permits and may rent the Kitchen.
- There were 3 facility reservations processed.
- There were 2 private rentals and 11 pattern rentals.
