





# Department of Public Works Week Ending January 10, 2013



#### ADMINISTRATION

- Kenny Hall and Jim Sterling held a supervisors' meeting on Monday.
- Jim Sterling, Frank Kellaher and Brian Townsend attended the Clean Water Trade Show sponsored by the Maryland Department of the Environment.
- Kenny Hall and Jim Sterling met with a contractor who is interested in providing COMAR inspections and preventative maintenance for vehicles.
- Jim Sterling met with the Assistant Director of Recreation, Joe McNeal, regarding the budget.
- Jim Sterling continued oversight of Pepco infrastructure work in the right-of-way.

#### STREET MAINTENANCE/SPECIAL DETAILS

- Applied crack seal on Ivy Lane most of the week.
- Pushed up debris at the Northway Fields compost site.
- Took down unwanted signs and checked for graffiti.
- Lowered and raised the Maryland and Greenbelt flags.
- Cleared storm drains throughout the City.
- Cleaned the salt trucks and removed the plows.
- Distributed salt on City streets starting early Friday morning.
- Transported risers to the Community Center.

#### **BUILDING MAINTENANCE**

- Replaced several lamps in the outside light fixtures at the Municipal Building.
- Assisted the contractor with fixing pipes for the HVAC system in the Greenbelt Theater.
- Replaced missing ceiling tile in the elevator alcove at the Community Center.
- Replaced lamps on two outdoor lights at the Youth Center.
- Performed preventative maintenance on the HVAC system at the Police Station.
- Provided cleaning services in all City buildings.
- Installed a new wall heater in the ladies room at Buddy Attick Park.

#### REFUSE/RECYCLING/SUSTAINABILITY

- Collected 33.49 tons of refuse and 49.22 tons of recyclable material.
- Composed an email to the Forest Preserve Advisory Board (FPAB) explaining the Forest Stewardship Program, the Chesapeake Bay Trust (CBT) grant, the Baltimore Washington Partners for Forest Stewardship (BWPFS) and some new projects. Alex Palmer of CHEARS and Public Works are working on issues such as cutting the English Ivy that is climbing up trees at Buddy Attick Park and protecting trees from beavers at the same location.
- Continued dialogue regarding the Greenbriar Mitigation Project with Green ACES.
- Coordinated with Green ACES members about attending the work session with Council and the Planning Department regarding the application to Sustainable Cities. Two members were able to attend the meeting.

#### HORTICULTURE/PARKS

- Continued with curbside leaf pick-up in all areas.
- Continued Christmas tree removal from posted areas.
- Assisted with refuse collection.
- Performed repairs on turf maintenance equipment.
- Installed wall padding mounting tracks at the Youth Center. This will allow the concessions window to be utilized.
- Applied magnesium chloride to sidewalks to melt ice on Friday.

#### **ADMINISTRATION:**

- Prepared and sent out materials for the PRAB meeting scheduled for Wednesday, January 15, at
   7:30pm in the Community Center. Representatives from the Public Safety Advisory Committee
   and Youth Advisory Committee have also been invited to attend.
- Reached out to individuals who can speak on playground surfaces. Two speakers have been contacted and asked to provide information on the possible health and/or environmental issues with different playground surfaces to include poured in place, rubber mulch and engineered wood fiber. Staff is still waiting for confirmation of their availability.
- Notice was written and put into News Review advertising the joint PRAB meeting for next week.
- Met with City Manager to review budget direction for Recreation Department and to briefly discuss findings from the Organization Assessment.
- Director visited the Golden Age Club meeting to install the new officers for 2014.
- Meeting is scheduled with the recreation management team for January 13 to review budget materials. Staff will also be meeting with City Treasurer next week and then the City Manager the week of January 21.
- Director is individually visiting other jurisdictions and meeting with colleagues to 'brainstorm' best practices/ideas and current trends in Maryland. This week, the director met with Howard County.
- Finalized information for the City Council agenda.
- Work on the FY 2015 budget continued. Met with Public Works staff to review building maintenance accounts.
- Staff is reviewing applications for vacant Recreation Coordinator position.

- The positions of Arts Assistant and Arts Education Specialist have been posted, in anticipation of vacancies at the end of January.
- Currently on view in the Greenbelt Community Center Art Gallery: bold watercolor paintings by Valerie Watson. The exhibit continues through February 7, with a closing reception at the February 2 Artful Afternoon.
- A benefit concert will be held at the Greenbelt Community Church on Sunday, January 12 at 7pm to raise funds for the Greenbelt Recreation Department's afterschool art programs at Springhill Lake Elementary School. Local bands Transatlantic Crossing and Harp 46 are donating their performances.
