## City Manager's Report Week Ending October 3, 2014

- 1. Included in Council's packet is Sage Policy Group's Economic Development Strategy for Greenbelt. We are working on finding a date for Sage to come brief Council on the report. Until Council has had a chance to review the report and meet with Sage, we are going to treat the report as internal and not release it publicly. Staff is reviewing the document and has identified a few minor edits.
- 2. At the City Manager Update work session, support was expressed for placing Council Action Request 2013-12, a petition for a camp fire ring at Northway Fields, on Council's agenda for action. Attached are summary thoughts on the matter from the Recreation Department. The key issues from staff's perspective are the safety issue given the nearby woods, the staffing which would be necessary given the activity and the remote location, and the history this area has for problems. The item will be placed on the October 27 agenda.
- 3. Attached is information sent out by email on September 29. It is crash data at the city's red light camera locations. On an annual basis, there are not many crashes and they are generally trending lower, except for the year 2012 at the intersection of Greenbelt Road and Cherrywood Lane which bears watching.
- 4. Along with Mayor Jordan and Mayor pro tem Davis, I attended the ribbon cutting for the headquarters of Bozzuto at Capital Office Park. Bozzuto is very happy to have been able to stay in the County and Greenbelt. They employ over 1,900 employees with 350 at their Greenbelt location. County Executive Baker, Council Chair Franklin and Council member Turner were also present.

## 5. Assistant City Manager

- a. Liz Park and I met with County Auditors who were conducting a review of Youth Services Bureau funding.
- b. Attended a CDBG workshop in Largo regarding applications for Program Year 41 (FY 2016).
- c. Drafted and transmitted renewal lease for the Fire Station. This will be on Council's October 28 agenda for approval.

- a. Continued assisting auditors in matters leading to completion of preliminary draft of Financial Statements which should be available soon.
- b. Attended the County's Tax Differential Meeting. A summary of the information presented is being prepared.

RE: CAMP FIRE RING

As requested by Council, staff has reviewed CAR #12 which is the petition for a fire-ring at the Northway Fields, Recreation staff could not agree on whether we should or should not have a fire-ring so, as suggested, I am listing the Department's pros and cons of having a fire-ring at Northway Fields.

## Some of the **pros** of having a fire-ring include:

- 1. Greenbelt Recreation Department would be a pioneer for this type of program
- 2. A fire-ring could facilitate a new programming area and could lead to a variety of recreation activities
- 3. Will help foster a good community atmosphere reaching out to the outdoor recreation clientele
- 4. Gives the City more of a presence at Northway Fields.
- 5. May lead to revitalization of the Northway site.
- 6. Possible revenue generator (due to staffing and upkeep there would have to be a fee associated with the rental)

#### Some of the cons include:

- 1. The Forest Preserve is very close by and prohibits this type of use.
- 2. The Northway Field location is notorious for inappropriate "afterhours" activity
- 3. Due to the nature of this activity, it would involve assistance from not only the Recreation Department who would issue the permits but also from the Police and Public Works Departments for security, safety and maintenance. This means additional expenditures when the budget is already tight. This would also mean additional duties for staff when they are many times already stretched beyond their 40 hour work week.

- 4. Also require more hours for part-time staff which would be additional costs to the budget
- 5. There is no water supply or restroom facility at Northway Fields

## Some other items of note:

Since the price range we are looking at would be in the same range as that offered at Greenbelt Park by the National Park Service (NPS), the logical question is should the City offer a duplicative service? Staff called Greenbelt Park and they advised they provide a fire ring for a fee to *guests only*. Outside user groups can come in but are required to rent a camp site before they are allowed to rent the fire-ring. The rough cost for the fire ring is about \$95 in addition to the camp site rental fee. Guests coming into the park who bring vehicles are also charged a fee.

As Recreation Director, I see both the pros and cons of the fire-ring but unless there was additional funding (for staff and supplies) and all **Departments** were in support, Recreation cannot take this on alone. After brief discussions with Public Works and the Police Department, it is my understanding that they are **not** in favor of a fire-ring at Northway for some of the same reasons that are listed above.

#### **Greenbelt Enclosed Campfire Ring Proposal**

I am proposing that a **campfire ring** be built on Greenbelt city property at Northway Fields. So that groups of people can have permitted fires and community gatherings in Greenbelt. This property should probably be non-Forest Preserve land but the city land advised by PRAB.

#### Reasons:

- (1) **Community Building:** Having fire, music, song, food and dance satisfies a new United Nations initiative to build strong and cohesive communities in non-disaster times.
- (2) **Healing / Therapy** Current research indicates that community based fire pit activity can support healing for adults and children dealing with trauma and / or grief as well as for diagnoses such as Terrets, ADD, ADHD, Asperger's, and sensory disabilities.
- (3) **Safety:** Lastly a campfire ring would encourage more people in wholesome groups to use the Northway Area at night so it would cut down on any rogue element using that area as in our past Greenbelt history.
- (4) During the creation of the Forest Preserve a plan for a Pavilion and fire pit were grandfathered in at that location.
- (5) There are no campfire rings in the Greenbelt area that kids can be taken too. (Note Mowatt Church has one but can only be used by Ancestral Knowledge and the local Boy Scout Troop. Also it is close to GHI housing and lots of use will probably bother the neighbors. So it is not used much. Greenbelt Park charges \$90 a night for use of a fire pit that is not that good and if you try and rent a camp site for a few hours they charge you for every two cars. Boy Scout Troop 740 was charged over \$125 for just a few hours.
- (6) **Enthusiastic community support**: Lastly when contacting groups for support for this idea I came into contact with many individuals who were absolutely ecstatic about the idea of a community fire pit. In fact I did not find a single person or group who was not extremely excited by the idea. This proposal has a lot of interest and support.

Groups who are interested in using the proposed fire pit area are: The Living Pine nature connection, community and mentoring project, The Committee to Save the Greenbelt, CHEARS, The Greenbelt Drum Circle Group, Local Boy Scout Troop 740 and Local Cub Scout Troop Pack 202, Beaver Dam Creek Watershed Watch Group, Camp Fire USA, The Norse group, and Girl Scout Troop 4816. As well as many excited Greenbelt citizens. (Note all groups listed except Boy Scout Troop 740 (Berwyn Heights) are Greenbelt groups).

#### What is needed?

- (1) Site: there are four possible locations all by Northway Fields at the end of the dirt road, all on PRAB advised land, maybe more (a) Area by the large dirt piles which is a pretty trashed area. Requires the cutting of one small dead tree and lots of scrub invasives. This area is already flat and needs the least amount of work to get ready (b) Area below and off to the side of the observatory. Needs a little bit of grading but maybe the best site. (c) Area which is just below area (b) but in the wooded section. Would need to cut down a few trees (Virginia Pine) and do some clearing and maybe a little grading. (d) Inside the Y area where the road splits. Lots of trash needs to be picked up and some clearing and grading. Not a good area but possible. Two areas can be cleared and made ready by volunteers if site (a) is picked with little city help. Site (b) too if city does the grading. Also all possible site areas are walkable to fire pit from parking areas without need to walk on the road (safety precaution).
- (2) **Trees**: Planting of Evergreen Trees. Should be mostly white pine trees to surround the site. Helps block fire from wind and makes a beautiful spot. White pine is a native plant and our town symbol. Second ring of trees should be Stone pines or Korean pines which look like white pines but have huge pinecones which people can gather for the nuts. (very healthy)

## Other logistics:

- (3) **Sign** for rules and whether there is a Fire ban or not. Fire ban sign should be able to flip the signage for fires or no fires.
- (4) Police patrol to come by once a night.
- (5) Agreement with Fire Dept. Mowatt is required to have a 5 gallon bucket full of water at the site. The Northway site is more remote. I think two 5 gallon buckets should be used.
- (6) Two more trash cans put in place near site.
- (7) Log benches that can be rolled or moved back or forward. (Sometimes people want to roast marsh mallows sometimes they want to dance).
- (8) Cement and 10 to 20 large rocks so fire pit stays a certain size.
- (9) Future: small rough cut open shed like building that two port-o-johns can be slid into and keep the park area looking nice. No permit needed because of small square footage. Port-o-johns should be placed out there so people do not leave their excrement in hidden places.
- (10)Future: Possible metal grate that can be locked over fire pit when not in use. Probably will not be needed.
- (11)Probable cost under \$1000. Cost would be for rocks, cement (probably already have) and mostly trees.


# Crash Data at Red Light Camera Intersections <u>Years: 2008-2012</u>

Last week the residents of Green Ridge House joined in the Active Aging Week celebration. Events, which were also open to community residents for this week, included Laughter Yoga, Healthy Mouth Screening and Presentation, Blood Pressure and Body Mass Index Screenings, Core Strengthening Exercise Class, and closing out the week-long festivities with a walk around the neighborhood and refreshments in the dining room.

Tom Patota, LCSW-C attended the Senior Forum at the Greenbelt Community Center on Sat 9/27/14.

Stephanie Powell, Crisis Intervention Counselor, attended a training called Transformational Relationships: Attachment-Centered Models of Intervention at School, Clinic, and Home that was sponsored by the Reginald S. Lourie Center in Rockville, MD. Attendees were shown models that the center uses whereby staff and parents interact with students to develop greater attachment in order to deepen the capacity for healthy relationships of children and caregivers. There was also a segment on trauma and how to support children with emotion dysregulation.

Liz Park, as MAYSB Chair, spoke to the State Advisory Board for Juvenile Services regarding Youth Service Bureaus and the proposed move of YSB funding from the Children's Cabinet Interagency Fund to the Department of Juvenile Services budget. 


