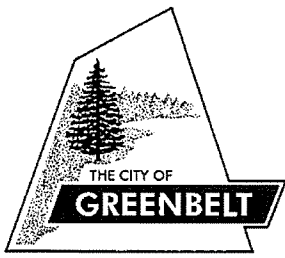

City Manager's Report Week Ending July 12, 2019

1. Included separately, please find a confidential packet on personnel and legal matters.
2. Attached is a draft promotional for the NASA Goddard Flight Center's 60th Anniversary activities. Residents, businesses, and visitors will be provided a list of possible things to do to celebrate the anniversary. The list is comprised of ideas from City staff, the Greenbelt Museum, NASA Goddard representatives, local business, university, school and utility partners. Please share feedback as staff would like to proceed with preparation of the publication.
3. Also attached is the Camp Enrollment report as of July 11.
4. Signed a personnel action for a new officer. The offer will be extended. Another candidate was called to reserve duty; the position will be held until his return from overseas.
5. Doctors Hospital's Chief Operating Officer has confirmed as that a hospital leader will be the speaker at the August 21st business coffee. Closer to the date the speaker will be confirmed from the new leadership team.
6. Dr. Liz Park checked with faith and spiritual based organization contact and confirmed that \$2,000 could be transferred from the Good Samaritan Fund to the Emergency Assistance Relief Fund for Greenbelt residents. This leaves about \$300 in the Samaritan Fund for people traveling through Greenbelt. Keep in mind that some payments to local apartment complexes on behalf of residents from the emergency fund to cover rent may be around \$400 each. Donations continue to be solicited to the emergency fund.
7. In follow-up to the Council work session, Ms. Molly Porter confirmed that the grant for art preservation expires in August 2020. Ms. Porter also confirmed that the conservationist's plan for the historic artwork at Roosevelt Center and the Community Center will address any identified needs beyond cleaning. This includes Councilmember Roberts's concern about the "knee" of the Mother and Child statue. Ms. Porter and other staff affirmed that the base of the Mother and Child has previously been worked on and replaced and will also be considered by the conservationist.

A few months ago this report noted lead testing conducted at the Community Center resulted in needed asbestos remediation in the windows. Please note that I misspoke during the recent work session and noted lead instead of asbestos abatement. As noted previously, according to Public Works the lead level in the windows was found to below standard levels with no work required. Following the window work, upon approval of the preservation plan, art preservation will start.

8. In follow-up to a concern raised at a Council work session regarding a private box truck decorated with advertising being parked at Buddy Attick Park during the July 4th Weekend, Chief Bowers noted that parking lot access will be among areas reviewed during the event after action report.
9. City Solicitor Todd Pounds advised that he is following up with departments on several items for updates. This includes several matters like memorandum of understandings with GHI on right of way, a local homeowner association for trespassing, as well as animal control and parking regulations.

10. Reviewing draft City/GHI Right of Way MOU language developed by Ms. Terri Hrubby and Mr. Pounds. I have asked for a few adjustments.
11. I asked Mr. Pounds to revisit the ownership of the Greenbelt Armory after I received a cryptic message from a State military representative indicating that ownership was about to change from the State to the Federal Government. The person that I was referred to has not yet provided a new contact for the facility. Subsequently, messages have been left to support the Labor Day Festival Committee in obtaining another agreement to use the Armory's parking lot for pre or post-event amusement ride staging area. The Committee representative has been advised that the City continues to try to find a contact for the Committee or vendor to secure the Armory staging area, yet other alternatives may need to be considered if the Federal and State Governments do not respond.
12. The umbrellas have returned to Roosevelt Center following past storm damage. This should address the concern raised by Mr. Roberts regarding bicyclists wanting a covered seating area beyond the restaurants' patio areas.
13. Thank you to public works for working with a contractor to address air conditioning challenges in the Municipal Building and Police Station. The police units required replacing parts, not the units. However, as noted previously, long-term, the units need to be replaced.
14. Mr. Williams processed the next summer renovation payment to the Friends of the Old Greenbelt Theatre for \$11,078.
15. Met with and/or teleconference with staff and City Solicitor Todd Pounds regarding personnel, legal and operational matters.
16. Attended the Council regular meeting, work session on Cherrywood Land Green and Complete Street, and a local business opening (Hook and Reel restaurant). Attended part of the circus camp performance, thank you to everyone, the performers were great!
17. Assistant City Manager
 - a. Attended the Regular Meeting.
 - b. Processed a TIF Requisition.
 - c. Worked on follow-up items from the June 13 CRAB Meeting.
18. City Treasurer
 - a. Completed audit confirmation letters which will be forwarded to the City's audit firm.
 - b. Began preparing audit schedules and reports. Audit field work begins on Monday, July 15.
19. Information Technology

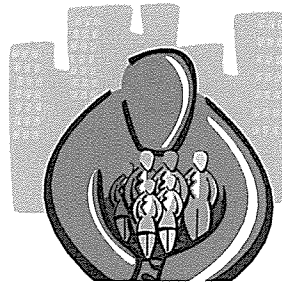

Darren Stephenson conducted the Drama Club, a 9 week dispute resolution and managing anger program. There were 13 adults who began the program in May; nine completed in July.

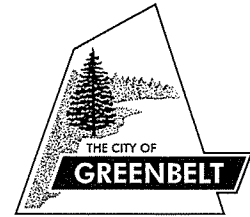
Liz Park participated in the Juvenile Diversion State Advisory Group meeting. The group heard a presentation from the Center for Children's Law and Policy.
