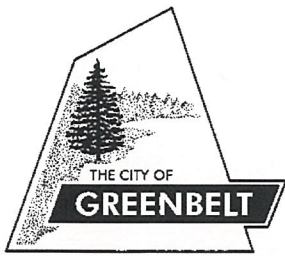

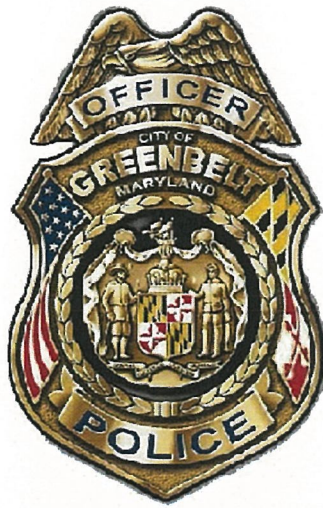

Greenbelt Officers Awarded Bronze Star For Arrest of Armed Subject

Four Greenbelt Police Officers were awarded Bronze Stars for their efforts in the apprehension of an armed and dangerous subject on September 27th, 2019. Officers responded to a report of a wanted subject who had reportedly stolen a handgun. Officers located the suspect, who then produced a loaded handgun and raised it towards the officers. The officers were able to disarm the suspect and place her into custody without further incident.

The Bronze Star is the third highest award an officer can receive and is awarded to those officers who have shown courage, intelligence and devotion of duty during the apprehension and arrest of an armed or dangerous suspect.

Congratulations go to Master Police Officer Jason Cressman, Corporal Michael Apgar, Sergeant Jermaine Gullede and Officer Dylan Davis.



Officers Receive African American History and Culture Training

Several Greenbelt officers attended African American History and Culture Training for Law Enforcement December 11th at the National Museum for African American Culture & History in Washington, D.C. During the next few months all officers and civilian personnel will receive this training.



Burglary Arrest

Tracy Kennedy Williams, 34, of Greenbelt was arrested and charged with First Degree Burglary by officers responding to a report of a man breaking out an apartment window and entering the residence in the 6100 block of Breezewood Court. The suspect left the home and was located a short time later still in possession of property belonging to the homeowner.

Officer Performs CPR On Overdose Victim

On December 27th officers responded to a residence in the 9100 block of Springhill Lane for a report of an overdose victim. MPO. Carlos Torres performed CPR on the unresponsive 19 year old male until the arrival of fire-board personnel. The victim was transported to UM Prince George's Hospital Center where he is said to be in critical condition. Investigation revealed that the victim ingested Percocet possibly laced with Fentanyl.

Camera In Place 7700 Block Hanover Parkway

In response to a series of shooting incidents in the 7700/7800 block of Hanover Parkway, a portable multi-lens camera system has been installed to aid in the monitoring of the area.

On December 21st the Greenbelt Police Department partnered with Target for the 13th annual Shop With A Cop, which gives needy kids the opportunity to shop for themselves and their loved ones, followed by a wrap party at the Greenbelt Volunteer Fire Department. Warrants Obtained In December 24th Shooting

The Greenbelt Criminal Investigations Unit has obtained arrest warrants in the December 24th shooting which took place in the 6200 block of Breezewood Drive. The warrant charge the suspect, a 24 year old man with no fixed address, with Attempt 1st Degree Murder, Attempt 2nd Degree Murder, 1st Degree Assault and 2nd Degree Assault. The warrants have been turned over to the U.S. Marshals for service.



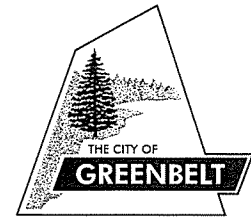
Greenbelt PD Partners With Ring To Use Neighbors And Neighbors Portal Apps

The Department signed an MOU to partner with Ring, Inc., to utilize the Neighbors App. Neighbors is an app that allows its users to report crimes within their neighborhood. With Neighbors Portal, officers can post info about crime and safety alerts in the community and view and comment on public posts as an identified law enforcement officer. The Video Request tool can be used by investigators to ask Ring to request video footage from device owners who are in the area of an active investigation.

YOUTH CENTER/ SPRINGHILL LAKE/PARK RANGERS/GREENBELT KIDS:

- Winter 2020 Activity Guide is now available on-line and printed guides are available in city buildings. Registration will continue on a space available basis until Winter classes begin on or after the week of January 4, 2020.
- Springhill Lake Recreation Center and the Youth Center opened at 12 pm on weekdays during the holiday break week.
