On Monday, Green Ridge House received 101 bags of COVID-19 prevention material as part of an information dissemination campaign by Doctors Community Hospital. Each resident received a bag containing soap, a mask, basic COVID-19 prevention flyers and a flyer on the COVID-19 testing site that opened in Prince George's County at the beginning of May.

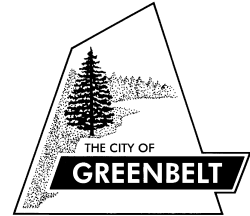
In addition, Green Ridge House will be participating in a Medication Disposal Initiative by the Maryland Department of Aging. Green Ridge House will receive free medication disposal pouches for each resident in mid-June. These pouches are being distributed to older adults as a means of safely disposing of prescription drugs that are expired or no longer being used, due to most medication drop off sites being closed due to COVID-19.

- Summer arts class registration is open for both residents and non-residents of Greenbelt. During the first four days of registration, 120 people enrolled in online visual arts and ceramics classes, ensuring that at least a dozen classes will run. In a few cases, local participants have enrolled in intergenerational programs with out of state family members, highlighting one of the unique benefits of online service delivery. Classes will begin during or after the week of June 15.
- Curbside pickups are ongoing to return fired ceramic wares to winter session class participants. Supplies are being acquired for summer programs. Staff are transporting clay orders in the absence of normal delivery service.
- Staff facilitated a meeting of the Greenbelt Arts Advisory Board and is working with them to coordinate reports on Roosevelt Center lighting and memorial bike racks. Staff generated a bike rack design with board input that AAB will be recommending.

## **THERAPEUTIC RECREATION:**

- Supervisor continues to research and provide content for the VRC.
- Supervisor posted to Social Media (Greenbelt Recreation).
- Scheduled several daily posts for the week
  - Greenbelt Day Weekend
  - Summer Connect Camp
  - Summer Classes
- Participated in weekly department staff Zoom meeting.
- Participated in MRPA Town Hall Meeting: Finding Sharing Our Ideas During COVID-19.
- Began plans for a virtual 4th of July celebration.
- Received 35 packets (COVID-19 Information & Word Search Books) from Prince George's County Department of Aging Nutrition Program.
- Supervisor worked with Prince George's County Department of Aging Nutrition Program to receive a week's worth of frozen meals for the Food & Friendship program and home-bound seniors; 36 seniors received meals this week.

## **PARK RANGERS:**

- Use of Northway fields continued to grow, but within social distancing compliance.
- A lot of grill use, despite caution tape and closure notifications.
- Information tent at BAP was helpful.
- GPD gave 100+ reusable masks for hand out, visitors were grateful.
