The suspect was transported to the Department of Corrections for a hearing before a District Court Commissioner. Investigation revealed the suspect and victim were engaged in a verbal altercation prior to the shooting.

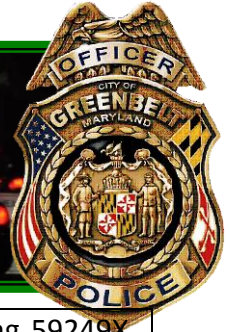

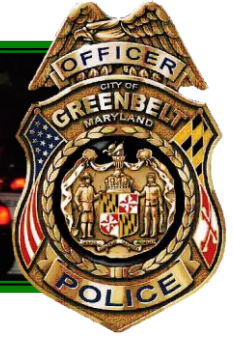

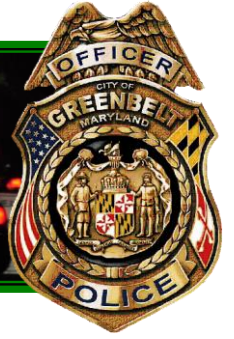
