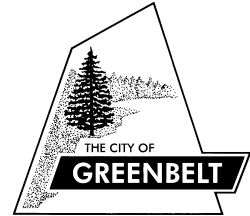
The GAIL Program conducted the first Produce Distribution since the Pandemic began in March 2020. We served 371 residents of which 56 were seniors and 148 were children.

In addition, GAIL conducted the first of two drive-thru flu clinics in partnership with the Prince George's County Health Department. The October 20 event was held at Beltway Plaza where 88 people received flu shots. The next event is scheduled at the Greenbelt Community Center on October 27.
