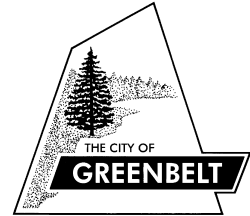
Museum Activities

- Press: article about Museum partnership with Old Greenbelt Theatre ran in the Summer/Fall edition of the e-newsletter of the Maryland Association of Historic District Commission entitled, *Maryland's Historic Districts*.
- Black History Month: confirmed event participation of one of first families to integrate Greenbelt in the late 1960s via phone meeting. Ongoing work to confirm other speakers.
- Online museum store: completed establishment of ecommerce/online store component to the Museum website. Ongoing work to populate online store with items for sale.
- Greenbelt Community Foundation grant: responded to GCF request to shift grant funds from 10A to a project that can be expedited more quickly. The original grant was for furnishings for the learning lab at the 10A Education and Visitor Center, which is still probably 1-2 years away. Submitted new proposal for grant funds to support 360 degree virtual tour of the Museum's historic house.
- FOGM new hire: along with FOGM President, held four virtual interviews with potential candidates for the FOGM office manager/bookkeeper position. Two were finalists.
- Webinar: attended webinar entitled, "Thinking Through Culture: Six Practical Steps to Addressing Race in Museums."
- #MuseumFromHome: edited, identified photographs, and published blog post about Halloween traditions in Greenbelt written by Education/Volunteer Coordinator.
- Research: responded to Greenbelt News Review request for a specific Halloween photograph.
- Museum lecture: ongoing work to schedule virtual Museum lecture for January on the film, *Green Book*.
- FOGM support: ongoing work on new CRM (customer relationship management) software for FOGM to better manage membership records. Data migration should take place soon.
- Weekly virtual meeting with Assistant City Manager.
- Completed visit and inspection of both 10A and 10B Crescent.
