Judye Hering attended the virtual COABE conference on Monday and Tuesday. COABE stands for Coalition on Adult Basic Education, which includes both ESOL and GED. Workshop sessions included: the virtual learner and its effects on the adult student, teaching strategies using Zoom, Best Practices, and motivating the student through COVID.
