

CREATIVE KIDS CAMP AT THE COMMUNITY CENTER

Campers will convene at the community center each weekday morning, head home for lunch, and rejoin their camp group for an afternoon Zoom session of guided activities and sharing time.

Weather permitting, we will begin each camp day outdoors and hold our first activity periods outside. We will move indoors later in the morning, as the temperature rises. The time for our transition to indoors will vary with the weather.

Note: Although we will prioritize outdoor time, parents should be aware that campers will be inside for at least a portion of the camp morning, and potentially all of it, depending on the weather. If you are not comfortable with your child participating in indoor group activities, please enroll in the Camp At Home option instead.

BONUS: Families enrolled in Camp At The Community Center will also receive the Camp At Home daily downloads. That way, if your campers have to miss a morning of attending in person, they can still participate in camp!

IMPORTANT NOTE: In the event of a communicable disease outbreak or severe weather, Camp-At-The-Center may be suspended or cancelled, and all campers will be moved to Camp-At-Home.

CAMP ENCORE

AGES 13-17

Join Director Kate Magill Robinson, and the Encore Artistic Team, as we spend Camp Encore 2021 exploring two of Shakespeare's most beloved comedies! Campers will meet on-line to rehearse and record the camp shows over Zoom, with the option of attending camp in person three afternoons per week.

For filming their scenes, campers who live locally will be provided costumes and props. The completed video productions will be shared with friends and family after the end of the camp session.

The optional in-person meetings will focus on fun theatre-related activities and improvisation. Weather permitting, in-person sessions will take place outdoors.

SESSION 1: MUCH ADO ABOUT NOTHING

There are few couples in literature who are more beloved than Beatrice and Benedick from Shakespeare's *Much Ado About Nothing*. On their thorny path to the altar, this power couple runs into detours involving an evil villain, hapless lovers, wacky servants, and a blundering town constable. When gossip and slander stain the reputation of young Hero, it takes the whole town banding together to bring the truth to light. It's a classical comedy, so everything ends well!

SESSION 2: TWELFTH NIGHT

In Shakespeare's *Twelfth Night*, Viola of Messina is cast upon the shore of Illyria, believing she is the sole survivor of a shipwreck. For her safety, she disguises herself as a young man and finds a job working for the Duke Orsino, carrying epistles of love to the duchess Olivia. Viola's disguise boomerangs when she falls in love with Orsino – and Olivia falls in loves with the young man Viola is pretending to be. More mix-ups occur when Viola's twin brother, Sebastian, turns up. Mistaken identities abound, but all will be happily resolved in the end!

NOTES

During Zoom Days, campers will need:

- Access to a device (laptop or tablet) and WiFi.
- A relatively quiet space where they can both move freely and speak up. (Campers cannot record scenes for the show in a car or a noisy setting.)

Campers will record most scenes for our shows at home over Zoom, but depending on the level of on-site participation, some dances and combat scenes may be recorded in person.

Campers who do not wish to attend the in-person sessions will be provided alternative athome projects.

Zoom sessions may be substituted for in-person sessions if the weather precludes meeting outdoors.

IMPORTANT NOTE: In the event of a communicable disease outbreak or severe weather, all in-person meetings may be suspended or cancelled, and camp will proceed via Zoom.

CAMP COVID PROTOCOLS

These protocols reflect public health orders in effect as of June 10, 2021. Please note that the protocols have been updated since the publication of the Camp Guide, due to improved COVID-19 incident rates and modifications to public health orders.

For All Camps:

- Temperature checks will be conducted when campers arrive at camp and at other times if needed. The daily symptom screening will be conducted at home by parents.
- Campers and staffers will be required to wear masks indoors. Campers must be masked upon arrival at the outdoor check-in station in the morning. Campers will be allowed to take their masks off, at the direction of the camp staff, for many outdoor activities. Staffers likewise will be unmasked much of the time while outdoors.
- Physical distancing of at least six feet will be the norm, indoors and outdoors, in all situations involving sustained interaction. There may be instances, especially during outdoor games, when participants may momentarily pass closer than six feet while in motion. Staffers will sometimes need to come into closer contact with campers in order to administer first aid or to render other assistance, in which case masks will be worn.
- Camper groups will be limited in size to fifteen persons, including campers and staffers.
- Camper groups will be podded, so that groups don't intermix.
- Indoor air quality will be enhanced through a combination of HEPA air cleaners and increased fresh air intake, via HVAC systems or open windows.
- Indoors, each camp group will use only one classroom each day, rather than rotating between rooms. The rooms will be sanitized each day.
- For art projects and other activities involving supplies, campers will be provided individual kits.
- Camp counselors will be assigned to one camp group throughout the session.
- We'll plan to take a mid-morning, super-distanced snack break outdoors.



SUMMER CLASSES... CERAMICS AND MORE!

In addition to our camp offerings, Greenbelt Recreation is excited to offer youth classes for arts, dance and sports enthusiasts! Sample listings are provided below that may hold special appeal for our Clay at the End of the Day alumnae. Registration for summer classes will begin on May 17 for Greenbelt residents and May 24 for non-residents.



Splish, splash - let's dive into creative clay fun! The joys of summer will inspire both sculptural and functional ceramic creations. We may make wonderful ceramic bowls to eat ice cream sundaes in or create sculptural ice cream itself. We may create creatures who live in the oceans, bay and lakes or paint koi, blue herons and sea scenes on our own ceramic platters. This class is appropriate for ALL ages and is suitable for both beginning and returning students. Students will receive clay, ceramic tools, ceramic underglazes and a wareboard on loan. Students will provide a water container, a sponge, a ruler, plastic utensils, and a sock filled with cornstarch. The instructor will provide more information at the start of class.

CAMPER REGISTRATION FORMS ARE AVAILABLE starting on page 15 of this brochure. Registration forms must be complete to process your registration and reserve your spot in camp. A COVID-19 Waiver is required for camp participation. Please sign the Waiver and submit it with the completed registration forms.

COMPLETED REGISTRATION FORMS should be submitted via email. All camp contact information is provided below. Forms will be accepted from Greenbelt residents* for Summer Camps beginning on Monday, April 19 at 10:00am and from non-residents beginning on Monday, May 3 at 10:00am. Registrations received before the start date/time will not be accepted. Please submit proof of Greenbelt residency to receive the resident rate. If registration via email is not possible, please contact the staff member designated below. Camper registration forms will be accepted on an ongoing basis until all slots are filled. At that point, interested persons' names will be placed on a waiting list. Those persons will be contacted in the order in which names were taken if/when a slot becomes available.

* **GREENBELT RESIDENCY:** In order to qualify to receive the resident rates as listed in this brochure, you MUST provide CURRENT proof of Greenbelt residency in the form of a driver's license, MVA change of address form with a driver's license, or a lease. If you are unable to provide one of these documents at the time of registration, you will be charged the non-resident rate.
