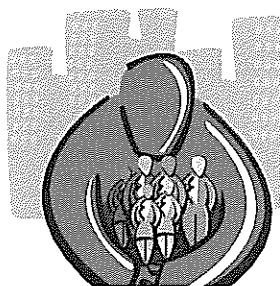

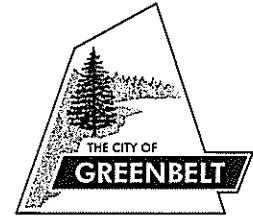
Museum Activities

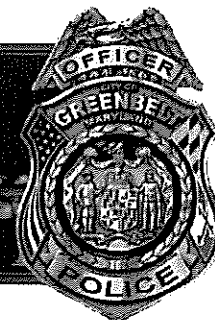

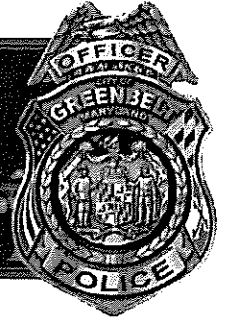

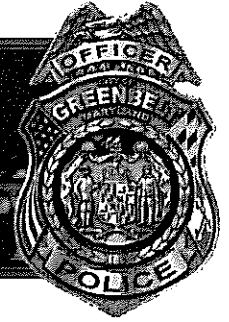


Animal Control Activity

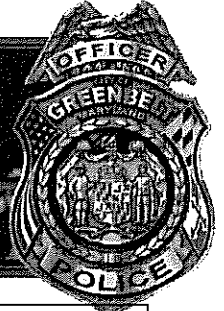

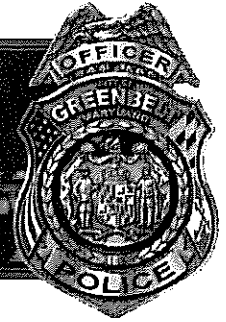

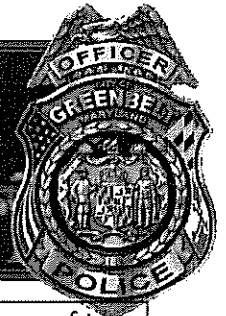
