Dear Governor Hogan:

On behalf of the Greenbelt City Council and the Greenbelt Racial Equity Alliance (GREA), I want to voice our opposition to ending the eviction moratorium beginning of COVID-19 pandemic and further request additional support services for those facing evictions across Maryland. Specifically, we urge you to extend or implement the following:

- Extend the Eviction Moratorium beyond August 15th, to give DHCD of Prince George's County additional time to disburse the remaining ERAP (Emergency Rental Assistance Program) money they have received from the March 2021 American Rescue Plan Act.
- Allocate state funding from your federal disbursement to provide necessary resources to pay for "civil representation" in eviction court.
- Allocate state funding from your federal disbursement to fund the "MDEC" (Maryland Electronic Courts), which would allow tenants to track their eviction filings online.

The paragraphs below provide a brief background on each request.

Eviction Moratorium. Several GREA Members attended a County Council briefing on July 1, given by Ms. Aspasia Xypolia, DHCD Director. She stated that her office has disbursed \$15.1M from the December federal stimulus bill. However, she has another \$27M from the March 2021 American Rescue Plan Act left to spend. So far, they have funded 48% of all Landlord Applications, but only 6% of all Tenant Applications. Of course, new applications are coming in everyday. New laws allow them to fund up to 18 months of back rent. Due to capacity issues, GREA is concerned that all of the money will not be disbursed by August 15th.

Civil Representation. In April 2021, the MD General Assembly passed HB18, giving tenants the "right to counsel" in landlord-tenant disputes and eviction proceedings. However, the companion bill HB31, which would have provided funding, did not pass. We request that federal funding received by the state from the various stimulus bills passed in late 2020 and March 2021 be allocated at the state and county level, to help pay for civil representation in eviction court.

Tracking of Eviction Cases. Maryland has a system for electronic filing of eviction cases. It is called MDEC (Maryland Electronic Courts) https://mdcourts.gov/mdec/about. Currently, the

system does not cover Baltimore City, Prince George's or Montgomery Counties. Therefore, a tenant is not able to look up their eviction case to see its status. Preliminary research says that the roll out of MDEC in these three jurisdictions may not be happening until October 2021 or beyond. We request that the state also provide funding for the MDEC to expand and expedite the tracking of eviction filings. Tenants should have the right to know the status of their case.

The City of Greenbelt strongly urges the State of Maryland to extend the eviction moratorium at least through September 2021 and to fund other important assistance to Maryland residents at risk of eviction.
