SCHEDULE A

MONETARY AND CAMPAIGN MATERIALS CONTRIBUTIONS

Itemize and record all contributions of money, financial or physical assets received for the reporting period whose value exceeds twenty-five dollars (\$25.00) in furtherance of the candidate's nomination and election.

SCHEDULE B

IN-KIND CONTRIBUTIONS

- 1 Record Itemized in kind contribution whose value exceeds twenty-five dollars (\$25.00) in furtherance of the candidate's nomination and election.
- 2 Services provided by service professionals such as accountant or bookkeeping, attorney or legal advisor or any other person such as an artist or designer, whose services the candidate would ordinarily pay.
