**Space Study Results**: Anne told us that a contractor has completed a space analysis of Greenbelt buildings and needs. The results will be presented at a City Council meeting on September 27<sup>th</sup>, at 7:30 P.M. The Community Center may have classrooms converted to office space, taking away rooms now being used by Seniors. Citizens may attend in person, virtually or view the recording. The acquisition of the Armory is being considered by both City Council and the County Fire Department. Elizabeth said that she participated in tutoring for a few weeks and noted that the rooms are used all the time. Having them taken over will be a real hardship for many of the groups used to meeting in City spaces. Betty stated that, "...some rooms need to stay as they are!"

**City Representative**: Henry inquired about the health of Silke, our Council representative. She is due for an operation of her eye due to stroke damage but is attending Council meetings. Anne said that the City Council values input from all advisory committees and the absence of a representative at our meetings does not diminish the value of our efforts.
