## ORDINANCE NUMBER 1330

AN ORDINANCE TO MAKE A SUPPLEMENTAL APPROPRIATION IN THE GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2013, IN THE AMOUNT OF FOUR HUNDRED AND FIFTY THOUSAND DOLLARS (\$450,000) FOR ADDITIONAL GENERAL FUND EXPENDITURES OVER THE APPROPRIATED AMOUNT

WHEREAS, General Fund expenditures for fiscal year 2013 were approved at \$24,961,600; and

WHEREAS, it is estimated that total expenditures will be more than the appropriation because of an additional fund transfer of \$200,000 to the 2001 Bond Fund: and

WHEREAS, additional funding is required to ensure that Public Safety remains within an authorized appropriation; and

WHEREAS, an appropriation of an additional \$450,000 will ensure compliance with the City Charter; and

WHEREAS, the City Manager and City Treasurer have certified that the City's fund balance is available for the purpose of making this appropriation in the amount of \$450,000; NOW, THEREFORE

BE IT ORDAINED by the Council of the City of Greenbelt, Maryland, that an additional \$450,000 shall be and hereby is appropriated as a supplemental appropriation for expenditures as shown below for the fiscal year beginning July 1, 2012, and ending June 30, 2013, in the General Fund:
