ORDINANCE NUMBER 1301

AN ORDINANCE TO AMEND CHAPTER 10, "LICENSES, PERMITS AND MISCELLANEOUS BUSINESS REGULATIONS," OF THE GREENBELT CITY CODE FOR THE PURPOSE OF REVISING ALARM USER PERMIT FEES

WHEREAS, it has been determined that alarm licensing should be done on an annual basis in order to ensure that all information associated with the alarm licensing is current,

NOW, THEREFORE, be it ordained by the Council of the City of Greenbelt, Maryland, that Chapter 10 of the City Code is hereby amended to read as follows:

Chapter 10

LICENSES, PERMITS AND MISCELLANEOUS BUSINESS REGULATIONS


DIVISION 2. ALARM SYSTEM REQUIREMENTS

Sec. 10-52. Alarm user permits.

(c) *Alarm user permit fees.*


- (1) There shall be a one hundred dollar (\$100.00) nonrefundable commercial/nonresidential alarm permit fee for the first ~~two (2) years~~ year. Payment shall accompany the application. It shall be the responsibility of the alarm user to pay the applicable fee.
- (2) There shall be a nonrefundable ~~biennial~~ annual commercial/nonresidential alarm renewal fee of one hundred dollars (\$100.00). It shall be the responsibility of the alarm user to pay the applicable fee. The fee must be paid prior to the expiration date of the current permit, or the permit will be subject to the reinstatement fee.
- (3) There shall be a twenty-five dollar (\$25.00) fee for duplicate registration stickers.
- (4) If an alarm user permit has been revoked or suspended or has expired, a reinstatement fee of one hundred dollars (\$100.00) shall be paid prior to the reinstatement or reissuance of the alarm permit.

ORDINANCE NUMBER 1300

AN ORDINANCE TO AMEND CHAPTER 8, "ELECTIONS" OF THE GREENBELT CITY CODE IN ORDER TO REVISE SECTION 8-1, "PRECINCTS" FOR THE PURPOSE OF ADDING A NEW PRECINCT

WHEREAS, in advance of the 2008 Primary Election, Prince George's County split Precinct 21-13 roughly in half and created a new Precinct 21-18; and

WHEREAS, since the City Code establishes City Election precincts using the same precinct designations as the County. NOW, THEREFORE,

BE IT ORDAINED by the Council of the City of Greenbelt, Maryland, that Chapter 8 of the City Code be amended to read as follows:

Chapter 8

ELECTIONS


ARTICLE I. IN GENERAL

Sec. 8-1. Precincts.

For purposes of city elections, the city shall be divided into ~~four (4)~~ five (5) precincts, and the boundaries of each precinct shall be the same as those established by the county for those portions of Precincts 3, 6, 8, 13 and ~~13~~18 of the Twenty-first Election District located within the city.


