## ORDINANCE NUMBER 1247

AN ORDINANCE TO MAKE A SUPPLEMENTAL APPROPRIATION IN THE GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2004, IN THE AMOUNT OF EIGHT HUNDRED THOUSAND (\$800,000) FOR ADDITIONAL EXPENDITURES OVER THE APPROPRIATED AMOUNT

WHEREAS, General Fund expenditures for fiscal year 2004 were approved at \$17,989,700; and

WHEREAS, it is estimated that total expenditures will be more than the appropriation because of an increase in worker compensation insurance, fuel for motor vehicles, natural gas and electric expenditures; and

WHEREAS, total expenditures will also increase because of an additional transfer to the Debt Service Fund to purchase the Greenbelt Theatre; and

WHEREAS, an appropriation of an additional \$800,000 will ensure compliance with the City Charter; and

WHEREAS, the City Manager and City Treasurer have certified that the City's fund balance is available for the purpose of making this appropriation in the amount of \$800,000. NOW, THEREFORE

BE IT ORDAINED by the Council of the City of Greenbelt, Maryland, that an additional \$800,000 shall be and hereby is appropriated as a supplemental appropriation for expenditures as shown below for the fiscal year beginning July 1, 2003, and ending June 30, 2004, in the General Fund:
