- Review all pictures for accuracy and clarity.
- More information is needed on lake trail materials.
- Wordsmith and correct typos.

Phase 3, Neighborhood Design Center will be engaged to assist in creating a concept plan to include a park along Indian Creek and Indian Creek Trail.

- The "Learn 2 Earn" financial literacy program, will continue after a successful pilot program. The program targets high school students.
