- 1. An accurate plat or site plan drawn to scale (five copies).
- 2. Filing fee or financial hardship waiver request.
 - a. For single-family residential attached and detached: \$200, plus \$50 deposit for mailings and advertising
 - b. All others: \$1500, plus \$50 deposit for mailing and advertising
 - c. Sign posting fee: \$30 per sign
- 3. A signed statement of justification indicating why you need the variance, how the proposed variance will not impact the character of the immediate community, and how the variance meets the following three required criteria:
 - a. That special conditions and circumstances exist which are peculiar to the land such as narrowness, shallowness, shape, topography, or other extraordinary situations or conditions;
 - b. That strict application of the County Zoning ordinance will result in peculiar and unusual practical difficulties to the owner of the property; and
 - c. That the variance will not substantially impair the intent, purpose, or integrity of any applicable County general plan or County master plan.
- 4. Please note: The City of Greenbelt does not accept online application submittals. A complete application and payment must be submitted in person at the address provided at the top of this application.

Application for a variance is no assurance that it will be granted. The public hearing is for you and others interested in this case to state their positions.
