ADVISORY PLANNING BOARD REPORT TO COUNCIL

REPORT NO. 2013-3 May 17, 2013

SUBJECT: Draft Pedestrian and Bicyclist Master Plan - Transmittal

BACKGROUND: The Draft Pedestrian and Bicyclist Master Plan is the culmination of four years of work starting with preliminary discussions at APB meetings which were leveraged with a grant secured by the Department of Planning and Community Development from the Transportation/Land-Use Connections Program of the National Capital Region Transportation Planning Board at the Metropolitan Washington Council of Governments, the input of many residents, and hours of data review and deliberations by the Board and staff.

ANALYSIS: The Board and staff devoted significant time to develop a matrix and companion map that identifies specific locations for improvements to pedestrian and bicycling facilities. While the recommendations identified are extensive, it is anticipated that the City, the Board, and residents will bring forward additional locations that warrant attention and inclusion in the Plan over time. The Plan is designed and intended to be periodically updated.

The Board hopes that the City use the Plan as a resource during annual budget preparation and when appropriate funding opportunities are available to the City to invest in and improve pedestrian and bicyclist infrastructure and amenities.

The Board appreciates the opportunity to complete and present the Pedestrian and Bicyclist Master Plan to Greenbelt's City Council and looks forward to working with the City to integrate elements of the Plan as new assets that extend Greenbelt's historic role as a planned community.

RECOMMENDATION: The Board's intent is that the City sees the Plan as an agile document that is updated as its suggested remedies are implemented or resolved and new pedestrian and bicyclist needs are identified. The Board sees the Plan as a tool available to the Department of Planning and Community Development, Public Works, and the Greenbelt Police Department for planning, implementation, and education and enforcement. The Board also envisions the Plan as a resource for the annual Capital Improvements budget, serving to identify investment priorities and as a ready reference for pursuing appropriate funding opportunities to improve and enhance Greenbelt's pedestrian and bicycling infrastructure.

The Board recommends City Council schedule a public work session to discuss the draft master plan. After the public work session, staff will incorporate final edits, and the Board recommends City Council adopt the master plan as an official planning document.
