Molly Lester spoke to us about Public Arts Policy and about the impact generally of Public Arts Policy around our geographic area. She mentioned Mt. Rainier public art opening and talked about seminars on public arts policies. She asked the rhetorical question "How do we make public art that connects well and is embraced by the communities?" Part of the answer to this question is to include artists and community in a wide variety of conversations.

Specific resources for our consideration include, but of course are not limited to, at Bowie State, an exhibit by Ayokuule Odeleye between September 12 and October 31; Prince Georges Arts and Humanities Council economic viability proposal with Prince George's County Executive Rushern Baker.

Caitlin McGrath, film historian and President of the Friends of Old Greenbelt

Theater, updated the AAB on plans for the renovation of the historic Old Greenbelt Theatre. She presented the same power point slide show that she presented to the Greenbelt City Council, and reiterated information published in the Greenbelt News Review article on the same topic published in the September 26, 2013 edition entitled "Theater Renovation Project Put Back on Track by City Council" (http://www.greenbeltnewsreview.com/issues/GNR20130926.pdf).

The second reading of a proposed change to the bylaws occurred:

Mayor J. Davis (former) suggested that there is the potential that a recently trimmed tree trunk could be turned into a work of art. Nicole suggested we look at our Public Arts Policy and be guided by it in our approach. Perhaps we could add it to our list of potential art sites.
