REGULAR MEETING OF THE GREENBELT CITY COUNCIL held Monday, April 11, 2011.

Mayor Davis called the meeting to order at 8:00 p.m.

MINUTES OF COUNCIL MEETINGS:

Minutes of February 28, 2011: Under Council Reports, Ms. Mach said she did not attend the Greenbelt Community Foundation Tea. Under Award of Purchase – Replacement Police Vehicles, Ms. Mach noted she was referring to the number of vehicles approved for purchase this fiscal year, not the type of vehicle. With these corrections, Ms. Mach moved that the minutes be accepted. Mr. Putens seconded. The motion passed 6-0.

Minutes of April 4, 2011: Ms. Mach noted she was not present for this interview because she was attending the Parent Cooperative Preschool International meeting. With this correction, Ms. Mach moved that the minutes be accepted. Mr. Putens seconded. The motion passed 6-0.

ADMINISTRATIVE REPORTS:

Mr. McLaughlin announced a Family Fit Night event will be held on Friday evening at the Springhill Lake Recreation Center and the Celebration of Spring event will be held on Saturday, also at the Springhill Lake Recreation Center.

COUNCIL REPORTS:

Ms. Mach commented on the Prince George's Elected Municipal Women's meeting which she attended with Mayor Davis, and also on the Opening Day of Greenbelt Baseball which was attended by all of Council.

Mr. Jordan reported on the Prince George's Chamber of Commerce 2011 State of the Economy meeting and the Anacostia Watershed Cleanup event in Greenbelt West.

Ms. Pope commented on the Greenbelt Middle School ceremony for the Radical Readers Competition which was also attended by Governor O'Malley, Prince George's County School Superintendent Hite, Mayor Davis, Mr. Herling, Mr. Jordan and Mr. Putens.

Mayor Davis reported on the Franklin Park Summit which was also attended by Mr. Herling, Mr. Jordan, Ms. Pope and Mr. Putens. She also thanked all the local groups who had participated in the Anacostia Watershed cleanup events throughout the City.

COMMITTEE REPORTS: None

<u>CHANGE IN AGENDA ORDER</u>: Mr. Putens moved that Council consider Item #17, CSX Rail Intermodal Facility, as the next order of business. Mr. Jordan seconded. The motion passed 6-0.

CSX RAIL INTERMODAL FACILITY: Mayor Davis read the agenda comments.

Council discussed the proposal by the Maryland Department of Transportation to construct a rail intermodal facility at one of four possible sites, one site being the property west of MD Route 201 between Sunnyside Avenue and Powder Mill Road. Council noted a number of concerns with this site, which is currently undeveloped wetlands and forested flood plain and part of the Beltsville Agricultural Research Center (BARC).

Cary Coppick, 9-D Ridge Road, and Doug Love, 3-D Plateau Place, spoke in opposition to construction of the rail intermodal facility at the BARC location.

Mayor Davis moved that council send a letter to Beverly Swaim-Staley, Secretary of MDOT, indicating Council's opposition to further consideration of this property for the proposed rail intermodal facility and urging that it be removed from the list of possible sites. She also requested copies of the letter be sent to the federal representatives, BARC and the United States Department of Agriculture. Mr. Putens seconded. The motion passed 6-0.

LEGISLATION:

An Ordinance to Amend Chapter 2, "Administration," Article IV, "Ethics," of the Greenbelt City Code for the Purpose of Updating the Section on Financial Disclosure

Mayor Davis read the agenda comments. Mr. Putens introduced the resolution for second reading and moved that it be adopted. Ms. Pope seconded the motion.
