This is the third analysis of victim and witness needs and services compiled by the Greenbelt Police Department. The Greenbelt Police Department has the ability to provide for victim and witness assistance through a variety of resources available through the City and numerous private and public organizations in the Washington Metropolitan Area, especially within Prince George's County.

The Greenbelt Police Department does not have the financial resources to provide for a full-time Victim Advocate. However, the City of Greenbelt does have a social services department known as Greenbelt CARES. Greenbelt CARES was established in 1974 as a community-based, family-oriented counseling program dedicated to promoting responsible behavior and family management skills. Since that time Greenbelt CARES has added three crisis intervention counselors who work hand-in-hand with the Greenbelt Police Department to offer immediate services to individuals who come into contact with the police, often as victims or witnesses of crimes; people who need emergency psychiatric evaluations; or, assist officers in other tasks, such as death notifications.

Greenbelt CARES further provides prevention programs to deter individuals from becoming criminals. They provide out-patient counseling services, school based counseling, vocational and educational counseling, GED classes and a job bank.

More importantly, Greenbelt CARES provides immediate crisis counseling and short term (6-8 sessions) crisis counseling for crime victims as well as maintains an up-to-date referral listing of local resources, such as support groups for victim and witnesses of crimes. All of the services provided to Greenbelt residents and those who are referred by the Greenbelt Police Department are free of charge.

Maryland Annotated Code demands that the victims of crimes be provided an informational brochure. Until recently the brochure was only available in English, however now it is also available in Spanish.

### **Components of This Analysis**

Analyzed were the extent and major types of victimization within the City for calendar years 2008, 2009 and 2010. An inventory was created showing the types of services already provided within the City and extending out into Prince George's County, Maryland.

Departmental statistics were reviewed to determine the levels of victimization and locations by geographical area. In the 2008 Analysis, the majority of crime, roughly 60%, was recorded in Greenbelt West. Greenbelt East recorded roughly 30% and Historic Greenbelt 10%. These ratios had been a consistent trend over a period of ten years. In 2010 a slight shift in this trend was noted, with 51% recorded in Greenbelt West., 35% in Greenbelt East and 14% in Historic Greenbelt. A possible cause for this shift may be the increase in the amount of rental housing in the other areas of the City.

### **Analysis of Victim/Witness Assistance**

In preparing this analysis, allied agencies analyses were reviewed and evaluated to see how the Department's efforts to assist victims could improve, as well as see where victims and witnesses of crimes could obtain assistance. The following matrix illustrates services currently available to crime victims.

### **Needs and Available Services**

The needs of victims and witnesses vary depending upon the nature and extent of victimization. Under the Maryland Constitution and State law and guidelines, a crime victim must be treated with dignity, respect and sensitivity during all phases of the criminal justice process. After a crime has been committed and throughout the criminal justice process, different rights and services apply to specific victims.

In analyzing the needs of victims, area services and services providers were inventoried to determine the types of services they offer, as well as did not offer. The analysis demonstrated the City's commitment to providing quality services to its customers, while continuously trying to improve programs offered by the Department. The analysis also complies with National Law Enforcement Accreditation Standard 55.1.2, which requires the Department to complete an analysis of victim/witness assistance needs and available services within the agency's service area at least every three years or has access to a current analysis.

### Where Improvements Can Be Made to Provide Better Services and Reduce Victimization

The following are recommendations to improve the Department's assistance to victims and witnesses:

- Ensure that victims and/or witnesses to crimes have a ride to court if needed.
- Ensure that victims of crimes receive the brochure mandated by law is given to all crime victims and not just those who are victims of violent crimes. Attempt to obtain brochures on other languages.
- Add a link from the City web site to www.mdcrimevictims.org.
- Ensure that new employees understand the functions of Greenbelt CARES and their crisis intervention counselors.
- Continue to educate citizens through programs such as Neighborhood Watch.
- Ensure all employees are aware of the Maryland Crime Victim Resource Center.
- Have the Crime Prevention officer conduct group presentations concerning the rights of victims, victimization and ways that citizens can lessen their chances of being victimized, and how citizens can help each other and the police.

# MARYLAND CRIME VICTIM RESOURCE CENTER

### **HISTORY**

After their oldest daughter, Stephanie, was brutally murdered in 1982, her parents, Roberta and Vince Roper, learned they had few rights in the criminal justice system.

As a result they founded the agency that bore their daughter's name, the Stephanie Roper Committee and Foundation, now known as the Maryland Crime Victims' Resource Center, Inc.

Today, the Maryland Crime Victims' Resource Center, Inc. is one of the most successful grassroots organizations in the history of Maryland.

The Maryland Crime Victim Resource Center provides criminal justice information and education, support services, therapeutic individual family, and group counseling, legal information, referrals, and representation, and recently established a faith initiative to meet the spiritual needs of crime victims.

The Greenbelt Police Department has put together this analysis of victims' and witness' needs and available services within the City and Prince George's County, Maryland.

### Legal Clinic

Legal representation is one of the greatest unmet needs confronting victims of domestic violence throughout Maryland. The House of Ruth Maryland – Marjorie Cook Domestic Violence Legal Clinic helps more than 2,000 victims of domestic violence obtain protective orders, peace orders, divorce decrees, custody of their children and child support each year. We currently staff 17 attorneys plus paralegals and administrative staff throughout 6 offices in Maryland, including courthouse locations in Baltimore City, Hyattsville, Upper Marlboror and Montgomery County. To keep pace with the demand, more than 100 pro bono attorneys throughout Maryland have been trained and given technical support to prepare them for providing legal representation to battered women across the state.

Our staff attorneys provide civil legal representation to help women obtain:

- Protective orders
- Peace orders
- Divorce decrees
- Custody of their children
- Child support

- A victim may have the right to be notified of all hearings related to their case.
- A victim may have the right to be present at the trial.
- A victim is not required to speak to the defense attorneys or their investigators prior to the hearings.
- A victim or the victim's representative may have the right to address the court to describe the impact of the crime.
- A victim has the right to request restitution.
- A victim may have the right to be notified of any further hearings related to the defendant's sentence or release by the Division of Correction, Patuxent Institution, or the Parole Commission.

# Victims' Legal Rights in the Criminal Justice System

# Your Rights As A Victim in District Court

The District Court handles the following types of cases:

- Traffic cases
- Minor criminal cases
- Small claims
- Non-jury matters

If your offender is being prosecuted in the District Court of your county (or Baltimore City), the following are your rights as a victim of crime:

### Your Right to Be Treated with Dignity, Respect, and Sensitivity

Article 47 of the Maryland Declaration of Rights guarantees you, as the victim of crime, the right to be treated with dignity, respect, and sensitivity during all phases of the criminal justice process and by all agents of the criminal justice system.

### Your Right to Be Notified of Court Events Related to Your Case

Maryland does not provide for mandatory notification of court events in District Court cases. However, you should *always* inform the State's Attorney's Office if you wish to be notified. You can do this by writing a letter to the State's Attorney handling your case, sending a copy to the Clerk of the District Court, and a copy to the defense attorney. Be sure to include the defendant's name and case number. You are also eligible to receive notification through the VINE system, an automatic notification system.

### Your Right to Be Present at the Court Events Related to Your Case

You have the right to attend any court event that the Defendant has a right to attend. You *must* notify the State's Attorney prosecuting the case, and the District Court Clerk, that you wish to be present at the proceedings. It is important that both the State's Attorney and the District Court Clerk have your most recent address. If you are a witness to the crime, you may need to testify for the State. You may not be able to sit in the courtroom until after you testify. After you testify, you have the right to be present in the courtroom unless the Court determines otherwise. Please arrive at the courthouse

early on the day of the court event and remember to check in with the State's Attorney prosecuting the case when you arrive.

### Your Rights to Be Heard Before Sentencing is Imposed

You have the right to give written and oral victim impact statements to the Court before sentencing. You may do this by obtaining a form from the prosecuting State's Attorney or by writing your own statement detailing how the crime has impacted you and your family. As soon as you have completed your victim impact statement, send a copy to the State's Attorney's Office, the Clerk of the District Court, and the defense attorney. You also may have the right to speak at the sentencing. If you wish to do this, please notify the prosecuting State's Attorney in writing as soon as possible asking the prosecutor to request this right for you at Court. Be sure to include the case number and the Defendant's name on all correspondence.

### Your Right to Restitution from Your Offender

You have the right to request from your offender for out-of-pocket costs incurred as a direct result of the crime. To request this restitution, you should file a *Request for Restitution* with the State's Attorney prosecuting the case, the Clerk of the District Court Clerk, and the defense attorney. Your Request should detail all expenses and should include receipts and bills, if they are available. You also have the right to collect on a judgment of restitution.

Your Rights As A Victim in Circuit Court

The Circuit Courts in Maryland are general jurisdiction trial courts handling all trials including:

- More serious criminal cases
- Major civil cases
- o Family matters (including divorce, child custody, child support)
- Appeals from District Court, Orphan's Court, and administrative agencies

# Your Rights As A Victim in Circuit Court

The Circuit Court hears all jury trials, and oversees grand jury proceedings.

If your offender is being prosecuted in the Circuit Court of your county (or Baltimore City), the following are your rights as a victim of crime:

Your Right to Be Treated with Dignity, Respect, and Sensitivity

Article 47 of the Maryland Declaration of Rights guarantees you, as the victim of crime, the right to be treated with dignity, respect, and sensitivity during all phases of the criminal justice process and by all agents of the criminal justice system.

Your Right to Be Notified of Court Events Related to Your Case

Within 10 days of the filing of a petition to the Court, the State's Attorney's Office should send you a Crime Victim Notification and Demand for Rights form. You should complete this form and send it back to the State's Attorney's Office in the city or county where the crime occurred as soon as possible. When you file this form, the State's Attorney's Office is required by law to notify you of all events related to your case. You are also eligible to receive notification through the VINE system, an automatic notification system. VINE Fact Sheet

Your Right to Be Present at the Court Events Related to Your Case

You have the right to attend any court event that the Defendant has a right to attend. When you file the Crime Victim Notification and Demand for Rights form, you are notifying the State's Attorney's Office that you want to attend all court events. Arrive early on the day of the court event and notify the State's Attorney that you are there. If you are a witness to the crime, you may need to testify for the State. You may not be able to sit in the courtroom until after you testify. After you testify, you have the right to be present in the courtroom unless the Court determines otherwise.

Your Rights to Be Heard Before Sentencing is Imposed

You have the right to give written and oral victim impact statements to the Court before sentencing. You may do this by obtaining a form from the prosecuting State's Attorney or by writing your own statement detailing how the crime has impacted you and your family. As soon as you have completed your victim impact statement, send a copy to

the State's Attorney's Office, the Clerk of the Circuit Court, and the defense attorney.

### o Your Right to Restitution from Your Offender

You have the right to request from your offender out-of-pocket costs incurred as a direct result of the crime. To request this restitution, you should file a Request for Restitution with the State's Attorney prosecuting the case, the Clerk of the Circuit Court Clerk, and the defense attorney. Your Request should detail all expenses and should include receipts and bills, if they are available. You also have the right to collect on a judgment of restitution.

### Your Right to Be Informed of a Plea Agreement

You have the right to be informed of the terms and conditions of a plea agreement. Although you have the right to be notified of a plea agreement, you do not have the right to decide whether the plea is accepted by the Court. Only the judge has that right. You do, however, have the right to express your opinion about the plea agreement through your victim impact statement. If you do not agree with the plea, you should tell the Court and the State's Attorney.

# Your Rights As A Victim in Juvenile Court

Your Rights as a Victim in the Juvenile Justice System

The crime that has been committed against you may be handled in the Department of Juvenile Services. This means that the person charged with the crime is under the age of 18. Although many procedures are different between juvenile court and criminal court, you still have rights as the victim of the crime. The Maryland Constitution guarantees every victim of crime the right to be treated with dignity, respect, and sensitivity during all phases of the criminal justice system.

### Your Right to Be Notified of Court Events Related to Your Case

Within 10 days of the filing of a petition to the Court, the State's Attorney's Office should send you a Crime Victim Notification and Demand for Rights form. You should complete this form and send it back to the State's Attorney's Office in the city or county of the crime as soon as possible. When you file this form, the State's Attorney's Office is required by law to notify you of all events related to your case. Because your case is in juvenile court, there may be a "waiver hearing." A waiver hearing is a hearing to determine if the case against the juvenile should be handled in criminal court instead of juvenile court. If your case is initially charged in criminal court, you may also have a "reverse waiver hearing." In that hearing, the court decides whether the case should be moved back to juvenile court. You have a right to be notified of both these hearings. If you do not agree with the decision of the intake officer, you have a right to appeal the decision.

### Your Right to Be Present at the Court Events Related to Your Case

You have the right to attend any court event at which the Respondent has a right to attend. When you file the Crime Victim Notification and Demand for Rights form, you are notifying the State's Attorney's Office that you want to attend all court events, including a waiver or reverse waiver hearing as described above. Arrive early on the day of the court event and notify the State's Attorney that you are there. If you are a witness to the crime, you may need to testify. You may not be able to sit in the courtroom until after you testify. After you testify, you have the right to be present in the courtroom unless the Court determines otherwise.

### Your Right to Be Heard Before Sentencing is Imposed

You have the right to give written and oral victim impact statements to the Court before sentencing. You may do this by obtaining a form from the prosecuting State's Attorney or by writing your own statement detailing how the crime has impacted you and your family. As soon as you have completed your victim impact statement, send a copy to the State's Attorney's Office, the Clerk of the Juvenile Court, and the defense attorney. You also have the right to give a victim impact statement at a reverse waiver hearing if there is one in your case. You may do this by completing the victim impact statement as described above.

### Your Right to Restitution from Your Offender

You have the right to request from your offender for out-of-pocket costs incurred as a direct result of the crime. Because the offender is a juvenile, there is a \$10,000 limit on the amount of restitution that can be ordered. However, the Court can also order the

juvenile's parents to pay the restitution, as well as the juvenile. To request this restitution, you should file a Request for Restitution with the State's Attorney prosecuting the case, the Juvenile Court Clerk, and the defense attorney. Your Request should detail all expenses and should include receipts and bills, if they are available. You also have the right to collect on a judgment of restitution.

### Your Right to Be Informed of a Plea Agreement

You have the right to be informed of the terms and conditions of a plea agreement. Although you have the right to be notified of a plea agreement, you do not have the right to decide whether the plea is accepted by the Court. Only the judge has that right. You do, however, have the right to express your opinion about the plea agreement through your victim impact statement. If you do not agree with the plea, you should tell the Court and the State's Attorney.

The Maryland Crime Victims' Resource Center can provide assistance with the victim impact statement, requesting restitution, and additional court procedures that may arise.

### Office of The State's Attorney for Prince George's County

### Victim/Witness Assistance Unit

The State's Attorney's Office protects the rights of victims of crime and informs victims of their rights while they are involved in the criminal justice process.

### How We Help

- Our office provides direct assistance and information regarding court proceedings Monday through Friday, 8:30 a.m. to 5:00 p.m.
- We help solve problems caused by necessary court appearances, such as being excused from work.
- We provide a secure waiting room for witnesses making court appearances and escort them from the waiting room to the courtroom.
- We aid eligible victims in seeking court-ordered restitution for stolen property, as well as compensation for physical injuries.
- We provide information about social services available to crime victims.
- We encourage victims to describe in a written Victim Impact Statement the harm the crime has caused and how the crime has affected their lives. This Statement is used by the court in determining sentences.

Our well-trained staff of the Victim/Witness Assistance Unit helps guide victims and witnesses through the sometimes complex criminal justice system. The successful prosecution of criminal cases depends mainly on the support and assistance victims and witnesses provide, especially their willingness to testify in court. It is our responsibility to ensure that victims and witnesses are treated with dignity and respect.

The Victim/Witness Assistance Unit also conducts a bi-monthly **Homicide Survivors Support Group** which provides short-term grief counseling, referrals, informational materials and a resource library to spouses, children, siblings, parents and other family members of victims who have been murdered in Prince George's County.

### What You Need To Know

### Victim/Witness Coordinator

Victims and witnesses will be assigned a Victim/Witness Coordinator who will be available to answer questions and provide any assistance they need.

### Summons/Subpoena

A Deputy Sheriff will deliver a witness summons to victims and witnesses notifying them of the scheduled court date. The law requires them to appear on that date unless they have been excused by a representative of the State's Attorney's Office.

### **Defense Attorney**

Victims and witnesses have the right to decide whether or not they want to discuss the case with the defendant's attorney. If they choose to talk to the defendant's attorney, they may also request that a representative from the State's Attorney's Office be present during the interview. Victims and witnesses should always be sure they know who they are talking to when they discuss their case.

### Motion's Hearing

It may be necessary for victims and witnesses to appear at an informal hearing called a Motion's Hearing. This hearing is scheduled before the trial so that the evidence can be reviewed by the judge. Victims and witnesses should call their Victim/Witness Coordinator the day before the hearing to see if they will be needed.

### The Day of the Trial

The trial may not start as early as scheduled, so we suggest bringing reading material. Victims and witnesses will be questioned by the prosecutor, and then the defense attorney will have the opportunity to "cross examine" them. The defense attorney must protect his client's rights and this may involve closely scrutinizing the testimony. Victims and witnesses should not let the defense attorney's questions upset them. They should remain calm and answer the questions as best they can.

### Continuances

Court hearings cannot always take place as scheduled and may be "continued" (postponed). Victims and witnesses should call their Victim/Witness Coordinator the day before the trial to make sure there have been no last-minute changes. If they call the State's Attorney's Office after 5:00 p.m., a recorded message will also list changes.

### **Victim Impact Statement**

Everyone who has been a victim of a crime is asked to complete a Victim Impact Statement. This Statement is used by the court in determining sentences and is a chance for victims to describe how the crime has affected their lives.

### Pleas of Guilty

In some cases, the defendant will enter a plea of guilty to specific offenses. If a defendant pleads guilty, there will be no trial and the testimony of victims and witnesses will not be needed. Many defendants plead guilty before the trial, once they are convinced witnesses are willing to testify against them in court.

### Sentencing

The victim's appearance at the sentencing is not required. However, the victim's Victim Impact Statement will be given to the sentencing judge. Victims are informed by letter of the sentence imposed.

### **Keep Us Informed**

It is very important that victims and witnesses keep the State's Attorney's Office informed of their current address and telephone number so that we can contact them about their case. If victims or witnesses move, they must call their Victim/Witness Coordinator.
