Mayor Davis called the meeting to order at 8:08 p.m.

ROLL CALL was answered by Rodney M. Roberts, Alan Turnbull, Thomas X. White and by Judith F. Davis, Mayor. Edward V. J. Putens arrived at 8:12 p.m.

## **COMMITTEE REPORTS:**

**PETITIONS AND REQUESTS:** Don Comis of 3-G Laurel Hill expressed concern that the Greenbelt crime reports were not being provided to the Washington Post. Mayor Davis explained the City's policy of providing information to the News Review, Gazette and Journal.

Mr. Turnbull stated that City doesn't serve itself by providing information to news organizations outside the city. Mr. Putens stressed that the News Review and the Gazette have a wider distribution than the Washington Post and noted that the Post was not treating the city fairly. Mayor Davis noted that the city was planning to meet with representatives of the media and hoped to discuss this issue.

Sheldon Goldberg of 7848 Jacobs Drive, asked about the status of the grooved pavement along Greenbelt Road. He believed the grooved pavement was unsafe. Mr. McLaughlin agreed to investigate and get a report back to Council and Mr. Goldberg.

Mr. Ferguson briefed Council on the film festival at the Greenbelt Theater and noted that there was a kick-off ribbon cutting with prize giveways on Friday. He noted that the "Save the Theater" campaign was going very well.

A RESOLUTION PROVIDING FOR A REFERENDUM TO BE HELD AT A SPECIAL ELECTION ON TUESDAY, MARCH 9, 1999, FOR THE PURPOSE OF SUBMITTING TO THE VOTERS OF THE CITY OF GREENBELT, MARYLAND THE QUESTION OF APPROVING THE ANNEXATION OF THE PARKSIDE COMMUNITY

Mayor Davis read the agenda comments.

Mr. White favored question number 5. Ms. Davis favored number 3 or 5. Mr. Roberts could live with number 5, but hoped the question would be kept as short as possible. Mr. Turnbull also favored being as brief as possible. He favored number 2.

Mr. White moved the language in number 5. Mr. Putens seconded. Mr. Turnbull moved to amend number 5 by striking "enlarge its existing corporate boundaries by annexing" and change it to "annex." Mr. Roberts seconded. In response to questions, Mr. Manzi stated that annexation was a process and enlarging the boundaries was the end result of that process.

Sylvia Lewis, of 2-C Gardenway, did not believe the City needed to describe the issue in as much detail as was proposed because people will already know when they enter the booth. Barry Schlesinger, 105 Westway, stated that legal requirements are notorious for not being clear. He believed the ballot format did not need to follow the legal format and believed a shorter form was preferable.

Mr. Turnbull asked about why the ballot question did not contain more information about Resolution 879 and asked why the current resolution was not as detailed and complicated as 879. Mr. Manzi responded that State law recognized a for/against answer to the referendum. He stated that assuming the referendum passed then Resolution 879 would go into effect and if the referendum failed then Resolution 879 would be negated.

The amendment failed 2 to 3 (Putens, Davis, & White).

Mr. White moved to amend his motion to add in small font style, the paragraph in Mr. McLaughlin's 12/14 memo with the deletion of the last sentence. Mr. Putens seconded.

Mr. Roberts believed the additional wording was totally inappropriate and that the question on the ballot should be short and to the point. He stated that wording not included in the original resolution should not be included on the ballot.

Mr. White stated that he was persuaded to add the information because it embellishes on number 5. Mr. Turnbull believed that anyone going to the voting both would know what this issue is about. He stated that the question should be concise.

Ms. Lewis believed the electorate in Greenbelt was sophisticated. She stated that the electorate would remember any effort to obfuscate the issue. Mr. Roberts stated he would support number 5 as worded. He believed that the reference to "31 single family homes" in the memorandum was misleading.

Mr. Putens stated that Council was trying to make it very clear to the citizens. Mr. Roberts reiterated that the additional language was misleading and inappropriate. Mr. Roberts believed the public could be informed through advertisements and possibly a sample ballot.

Mayor Davis believed that there would be considerable awareness of the issue but wanted the question to be as clear as possible. Mr. Turnbull stated that the issue was to annex property not homes.

The amendment passed 3 to 2 (Roberts, Turnbull).

Mr. Roberts asked if there were numbers on permanent homeless in Prince George's County and Greenbelt. Ms. Hartman responded that they could get the numbers. Mr. Roberts asked what the city could do to help homeless in Greenbelt. Ms. Hartman responded that the city was good about helping its own through charitable programs. She stressed the need to lobby the County for more resources.

Mr. Putens found it strange that another County refused to admit a woman because she wasn't a resident of their County, when in fact she wasn't a resident of any County. Ms. Hartman responded that this was a strange situation but it was largely due to the lack of resources.

Mayor Davis stressed the need for donations to the Emergency Assistance Fund. She asked if the numbers of homeless were increasing. Ms. Hartman noted that in general in the County it was increasing particularly among children.

Mr. Turnbull agreed with the recommendation from the Crisis Intervention Counselors to lobby the County, but wasn't sure that the city was doing everything it could be doing. Mayor Davis suggested surveying other municipalities and possibly raising this as a 4-Cities issue.

Mr. McLaughlin agreed to produce a report that might indicate where the city could address the needs. Mr. Putens was particularly bothered by kids being homeless.

Mr. White moved the staff recommendation plus surveying other municipalities and raising this as a 4-cities issue and wanted to emphasize the lack of response to a published hotline. Mr. Roberts seconded. The motion passed 5 to 0.

AMENDMENT TO JOB DESCRIPTION - HUMAN RESOURCES OFFICER: Mayor Davis read the agenda comments. Mr. Putens hoped that the city would be consistent with all job descriptions. Mr. Putens moved that Council suspend the requirement for consideration at two meetings and approve the amended job description. Mr. Roberts seconded. The motion passed 5 to 0.

APPROVAL OF PURCHASE - FORD TAURUS: Mayor Davis read the agenda comments. Mr. Putens moved that Council approve the purchase of a Ford Taurus from Sheehy Ford of Marlow Heights through Anne Arundel County Bid #98-148 at a cost of \$14,268. Mr. Turnbull seconded. The motion passed 5 to 0.

INFORMATION ON OUTSIDE ATTORNEY: Mr. Manzi noted that he had been looking to find an attorney with experience in environmental issues and dealing with State Highway. Mr. Manzi was impressed with Mr. Liebesman's credentials and experience. Mr. Manzi indicated he was seeking authorization from Council for the city to retain Mr. Liebesman. Mr. Roberts moved that City engage the services of Mr. Liebesman. Mr. Putens seconded. The motion passed 5 to 0.

MEETINGS: Mr. Roberts moved that Council schedule an Executive Session under 10-508 (a) (7) to consult with on December 21 at 7:00 p.m. Mr. Turnbull seconded. The motion passed unanimously.

Council scheduled work sessions on February 1 on Year 2000 issue and February 3 on Recycling Committee and New Deal Cafe.

Mayor Davis wished everyone a safe, wonderful holiday and new year. Mr. Roberts wished everyone happy holidays, which was echoed by Mr. Putens, Mr. White and Mr. Turnbull.
