- 1. Presentation from the Advisory Planning Board (APB) on the Detailed Site Plan (DSP) for Greenbelt Station North Core/Metro Parking:
 - 1.1 WMATA Parking Garage
 - 1.2 Greenbelt Station Parkway, Greenbelt Metro Drive and Greenbelt Access Drive
 - 1.3 Because this is a transit oriented development it has an expedited review TOD.
 - 1.4 New road Greenbelt Station parkway will connect to the south core. Various levels, zoned for mixed use development, LEED silver or better, the developer might go for platinum.
 - 1.5 Discussion ensued with questions from attendants. John Krouse from College Park is concerned about the filling in of the existing stormwater pond that would have to be constructed on College Park/Hollywood land, so the stormwater will not be mitigated in site according to this plan. The parking garage is planned on top of the existing pond. The County needs to have an updated stormwater management plan (currently it's not).
 - 1.6 Channel is being redirected into the vernal pools and wetlands; we would like to see an impact statement. Green ACES wants to submit a comment on this.
 - 1.7 Can contingencies be created on the approval? Yes.
 - 1.8 Work-session on Monday, January 30, 2017 at Council Chambers. All are invited.
 - 1.9 Who are the experts in the group? Lutz, Ben, John, Susan will provide comments and send to Luisa to then send to the entire group for approval and then to Jessica to take to Council on Monday.
