 - a. Kickoff waiting for quorum
- 2. Councilwoman Mach Updates/comments
 - a. Greenbelt Theater Operations work is progressing on moving forward restoration
 - Council is seeking more community involvement on how to implement necessary modifications
 - 1. February opening
 - 2. Council decision will be made Monday, January 26
 - 3. Decision will incorporate more family type films
 - 4. Individual concerns were stated about an extension of New Deal were stated that the New Deal should remain the New Deal and the Theater should remain the Theater
 - ii. Youth Sports was discussed
 - iii. Economic Development Advisory board was also discussed as a new board
 - iv. Minimum Wage concerns over the salary increases versus the recoil of the loss of good will.

 - ii. This seems like a face saving effort by the school board until the Goddard School can reclaim the remaining space.

- a. Discussion w/ Public Works Staff Present
 - i. Scope of job parks and grounds is new
- b. Lake Park Master Plan
 - i. Has reviewed the plan and understands the debates over the policy
 - ii. Lola provided a history of the lake park master plan changes over the past 20 years. The revised committee is looking to create a policy that is broad yet specific to address certain issues
 - iii. 1990 document is the approved document that is currently in use
 - iv. Discussed updates
 - 1. Playgrounds and GIS
 - 2. Surfacing one of our suggestions is making surfacing available via web access
 - 3. Global Information System of the inventory of the playground equipment as part of the master plan making the playground equipment appropriate for age groups.
 - 4. Inventory was discussed as not being necessary for the master plan.
