I understand:

- There are certain dangers, risks, and hazards inherent in the use of the Skate Park, including but not limited to falling and /or colliding with fixed or moveable structures and/or participants;
- Conditions in the Skate Park may become more hazardous or dangerous during the use of the Skate Park due to changes in weather, temperature, the actions of other users of the Skate Park, and/or other changes in circumstances;
- 3) The potential consequences of using the Skate Park include, but are not limited to, the possibility of property damage and/or bodily injury, including death, permanent disability, and other serious bodily injury;
- 4) The rules and regulations for use of the Skate Park as explained in any written materials and /or explained by City Staff;
- 5) Permission of the City to use the Skate Park is conditioned on compliance with the Skate Park rules and the directions of City staff;
