GREENBELT SKATE PARK PARTICIPATION AGREEMENT ASSUMPTION OF RISK, LIABILITY AND INDEMNIFICATION FOR PARTICIPANT

NOTE: This Participation Agreement/Assumption of Risk Liability Release and Indemnification must be signed and on-file with the City of Greenbelt Department of Recreation as a condition precedent for using the City of Greenbelt Skate Park. Persons not registered with the City are not permitted to use the Skate Park and are subject to citation. **If participant is a minor and his or her parent or legal guardian is not present at the time the waiver is signed and submitted, waiver must be notarized.** Participation Agreement must be submitted at time of registration.

PARTICIPANTS/PARENTS (if participant is 17 years of age or younger): Please read (or help your child read) and understand the following:

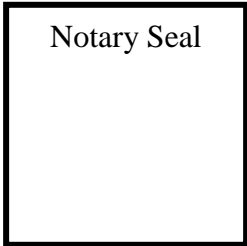
I understand:

- 1) There are certain dangers, risks, and hazards inherent in the use of the Skate Park, including but not limited to falling and /or colliding with fixed or moveable structures and/or participants;
- 2) Conditions in the Skate Park may become more hazardous or dangerous during the use of the Skate Park due to changes in weather, temperature, the actions of other users of the Skate Park, and/or other changes in circumstances;
- 3) The potential consequences of using the Skate Park include, but are not limited to, the possibility of property damage and/or bodily injury, including death, permanent disability, and other serious bodily injury;
- 4) The rules and regulations for use of the Skate Park as explained in any written materials and /or explained by City Staff;
- 5) Permission of the City to use the Skate Park is conditioned on compliance with the Skate Park rules and the directions of City staff;
- 6) The City requires participants to wear certain protective equipment as set forth in the Skate Park rules.

I agree:

- 1) I use the Skate Park at my own risk and that the City of Greenbelt, its officers, employees, agents, and representatives shall not be liable to me for any damage or injury, whatsoever, to my person or property arising out of or in connection with my use of, or presence in, the Skate Park;
- 2) To follow the directions of the City staff while in the Skate Park;
- 3) To inform a City staff member of any dangerous or potentially hazardous situation I may observe;
- 4) It is up to me, as a user of the Skate Park, to determine if I have the skills necessary to safely use any equipment contained within the Skate Park;
- 5) To abide by the Skate Park rules, a copy of which is attached hereto and initialed by me, as they may be amended, and such other rules as may be posted at the Skate Park.

Parent: By my signatures below, I hereby certify that I have reviewed the above with my child and that he/she understands his/her risks and responsibilities as a user of the Skate Park. I further certify that I fully understand and acknowledge said risks and responsibilities, hereby grant permission for my minor child to use the Skate Park.

In consideration of participant _____ receiving permission from the City of Greenbelt
(Applicant's Name)

to use the City of Greenbelt Skate Park (the "Skate Park"), the undersigned participant and, where participant is a minor, his/her parent hereby knowingly and voluntarily agree, on behalf of themselves and their heirs, successors, and assigns to:

- a) assume responsibility for all risks of loss, damage, or injury (including but not limited to disability and/or death) that may be sustained by participants or participant's property, which may arise out of, result from, or be associated with participant's use of, or presence in, the Skate Park, whether arising from the negligence of the City of Greenbelt or any of its agents, officers, employees, and representatives, or otherwise.
- b) forever release and discharge the City of Greenbelt, and all of its agents, officers, employees, and representatives from liability for any and all bodily injury (including but not limited to disability and/or death), property damage, and/or other loss whatsoever which may arise out of, result from directly or indirectly, or be associated with participant's use of, or presence in, the Skate Park, whether arising from the negligence of the City of Greenbelt or any of its agents, officers, employees, and representatives, or otherwise.
- c) hold harmless and indemnify the City of Greenbelt or any of its agents, officers, employees, and representatives from liability for any and all claims, demands, or any action whatsoever for injuries, damages, or losses to any person (including but not limited to disability and/or death) or property which may arise out of, result from, or be associated with participant's use of, or presence in, the Skate Park, whether said injury, damage, or loss is due to the negligence of the City of Greenbelt or any of its agents, officers, employees, or representative, or otherwise.
- d) This release/indemnification is to be interpreted in its broadest legal sense to protect the City of Greenbelt and any of its employees, agents, officers or representatives.
