11. Adoption Of The Budget

Reference:

Memo, M. McLaughlin and J. Williams, 05/18/2016

The City Council has nearly completed its budget process which began when the proposed fiscal year 2017 budget was presented to Council on March 29. Since then, Council has held eight public work sessions to consider the budget. On April 25, the City Council held a public hearing in accordance with City Charter requirements. A list of changes was prepared based on Council discussion at the final budget review work session on May 16. Council held a second public hearing on May 23 to receive public input on these changes. The budget is now ready for adoption. The City Charter requires that the budget be adopted by June 10 for the fiscal year starting July 1.

Included in Council's packet is a memo listing the changes that have been suggested to the budget as it was proposed on March 29. Council should vote on each of these changes and then on the new total. Once the changes have been approved, Council can proceed to the next item of business, the ordinance to appropriate the funds included in the budget. (CM)

Section 51 of the City Charter states that "immediately upon adoption of the budget, the City Council shall adopt an ordinance appropriating funds for the ensuing year....to include a summary of estimated income.... and levy all property taxes and other taxes required to realize the income estimated."

Having amended the City Manager's proposed budget, Council now must introduce an ordinance to adopt the budget, appropriate funds, and establish tax rates for real and personal property for FY 2017. All funds have been incorporated into one ordinance.

It is recommended that Council introduce the ordinance, suspend the rules, and adopt the ordinance at this meeting. (CM)

Note: Per Council's Standing Rules, six (6) votes in the affirmative are needed in order to suspend the rules. If the budget ordinance is not adopted tonight, a special meeting will have to be scheduled on or before June 10.

13. Greater Baltimore Wilderness Coalition

The City has been a participating member of the Baltimore-Washington Partners in Forest Stewardship (BWPFS) since June 2011. Recently, the BWPFS Steering Committee agreed to join with other federal, state, local area governments, and nonprofit organizations to expand the area of stewardship, restoration and conservation of the region. The members of this larger area will be called the Greater Baltimore Wilderness Coalition (GBWC).

The GBWC is similar to the BWPFS with quarterly meetings and the exchange of information. BWPFS members are being asked to sign the GBWC Accord (Accord) since it is consistent with the goals of the BWPFS. The Accord has been approved by 23 other organizations, including the Maryland National Capital Park and Planning Commission and the City of Bowie.

Gary Allen, Co-Chair of the BWPFS and member of the GBWC Steering Committee, will be present at tonight's meeting.

It is recommended Council approve the City's participation in the GBWC and direct the City Manager to sign the GBWC Accord. (CM)

14. Program Open Space (POS) FY 2017 Annual Program (R)

Reference:

The City's FY 2017 Annual Program Open Space (POS) Program is due to the Maryland-

National Capital Park and Planning Commission (M-NCPPC) on June 22, 2016. The City has been notified that the County will be receiving a total of \$3,258,859 in FY 2017 POS funds. Based on the results of the 2010 Census the City will be receiving \$87,011. Since the County is meeting the State's requirement that 50% of local POS funds be used for acquisition projects, the County is allowing jurisdictions to use 100% of their POS allocation towards development projects if they desire.

The City has \$900,021 in POS funding encumbered for the following development projects: Greenbelt Aquatic and Fitness Center Improvements Phase III, Community Center Facility Upgrades, Buddy Attick Park Master Plan Improvements, Greenbelt Aquatic and Fitness Center Phase II and Springhill Lake Recreation Center Expansion. The City also has \$62,948 in unencumbered acquisition funds and \$175,076 in unencumbered development funds that are shown in the proposed FY 2017 Annual Program.

Consistent with the City's adopted FY 2017 budget, staff is proposing the City's FY 2017 POS funds and some of FY 2016 POS funds be allocated to the Community Center HVAC project to bring the total POS funds allocated to this project to \$408,750. The proposed FY 2017 Annual program also proposes to allocate \$36,326 in FY 2016 POS funds to the Community Center Playground Renovation project, which did not receive the requested Community Parks and Playground funding. In order to cover the entire cost of this project, additional funding would have to be transferred from the Springhill Lake Recreation Center Expansion and/or other encumbered project. The Annual Program continues to include \$62,948 for land acquisition.

It is recommended that Council approve the City's FY 2017 Program Open Space Annual Program as proposed. (TH)

Judith F. Davis Mayor Pro Tem WORK SESSION OF THE GREENBELT CITY COUNCIL held Wednesday, May 11, 2016, for the purpose of reviewing the Green Ridge House section of the Proposed FY 2017 Budget.

Mayor Jordan started the meeting at 7:36 p.m. It was held in the Dining Room at Green Ridge House.

PRESENT WERE: Councilmembers Konrad E. Herling, Silke I. Pope, Edward V. J. Putens, Rodney M. Roberts and Mayor Emmett V. Jordan. Councilmember Leta M. Mach was out of the country. Councilmember Judith F. Davis had a prior commitment and was unable to attend.

STAFF PRESENT WERE: Michael P. McLaughlin, City Manager; Joyce Kolenky, Green Ridge House Service Coordinator; Christal Batey, Community Resource Advocate; and Cindy Murray, City Clerk.

ALSO PRESENT WERE: Steve Seh, Kim Potts and Patty Ramsburg of Community Realty Company.

Council reviewed the Green Ridge House section of the budget. Ms. Potts reported on the accomplishments for FY 2016. She advised that there are currently 91 people on the waiting list for apartments.

In response to a question about the proposed budget for maintenance expense, Ms. Potts explained that Green Ridge House has its last inspection from the Real Estate Assessment Center about three years ago so a new inspection is expected sometime this year. She commented on the stringent requirement of this inspection.

Ms. Potts said a dead tree in the front of the building is scheduled to be removed. Mayor Jordan mentioned that the Advisory Committee on Trees has developed a list of preferred trees for planting in the City.

Ms. Batey reported that the Greenbelt Assistance in Living (GAIL) Program conducted a resident satisfaction survey during November 2015 for residents of Green Ridge House. She said 33 out of the 101 residents completed the survey. Ms. Batey reviewed the survey results noting that 97% of respondents indicated they were very satisfied with their unit, the building and the neighborhood, and 94% were very satisfied or satisfied with the management of the building.

Mr. Seh and Ms. Potts then reviewed the proposed capital expenses planned for FY 2017 including apartment renovations as needed, replacement windows as needed, elevator upgrades, and various common area renovations.

Mr. Herling asked about recycling at Green Ridge House. Ms. Potts said Green Ridge House has been experiencing a problem with contaminents (including needles) being deposited in its recycling container. She reviewed the steps management has taken to address the problem, including holding a mandatory meeting with all residents. Ms. Potts noted that this problem occurs in the evenings and on weekends when management is not present. After discussion, Council suggested Ms. Potts contact Luisa Robles, the City's Sustainability Coordinator, and set up a meeting regarding recycling with Green Ridge House residents.

Raymond Cote, resident, suggested that smoking be prohibited on Green Ridge House property. He said when smokers use the designated smoking areas outside, the smoke prohibits use of adjacent areas (such as terrace) by other residents. Ms. Potts and Mr. Seh said management would look into the problem.

Krystyna O'Neill, resident, reported that she had difficulty maneuvering her power wheelchair on the sidewalk from Ridge Road (by the crosswalk) due to the steep grade. Mr. McLaughlin said the City will look at this sidewalk.

Carolyn Kepler, resident, spoke about the activities of the Green Ridge House Residents Association.

Mayor Jordan and Council thanked everyone for attending.

The meeting ended at 9:12 p.m.

Subject: Proposed Redesign Plan for Buddy Attick Park Parking Lot

Background: At the Park and Recreation Advisory Board's (PRAB) May 18, 2016 meeting, the Board considered the Greenbelt City Council's request regarding the proposed redesign plan for the Buddy Attick Park(BAP) parking lot. Sharon Bradley of Bradley Site Design, Inc. presented two site plan options. Terri Hruby, Assistant Director of Planning, City of Greenbelt also was present.

Both site plans were designed to improve storm water management and improve the pedestrian entrances from the parking lot. Option #1 had 99 parking spots and a wider bio swale in the center of the parking lot, but removed one row of pine trees. Option #2 showed 103 parking spots with a narrower bio swale, but retained both rows of pine trees.

Discussion: Generally PRAB liked the concept of improving the green space in the parking lot, defining the pedestrian access points and increasing storm water management. Several questions and concerns were raised by the Board: 1) Would there be any funds to improve the interior pathways leading from the newly established entrances? PRAB has long advocated for pervious hardening of the pathway from the parking lot and creating an ADA accessible pathway from the playground/restroom area to the lakeside path. 2) Is a permit lot for Greenbelters necessary? 3) Can the permit parking be located closer to Public Works buildings for the City employees? 4) Should both rows of white pines be removed now (due to tree health and age) allowing for more green storm water management in their place? 5) Could a pedestrian pathway from Crescent be established to safely lead people into the park from cars parked on Crescent Road? 6) Where would bike racks be located? 7) Could a configuration be found to allow for safe pedestrian drop off at the entrances from the parking lot?

Conclusions: PRAB would prefer a more comprehensive plan for Buddy Attick Park rather than piecemeal improvements. PRAB continues to advocate for a revision of the BAP master plan. PRAB would prefer addressing entrance paths in conjunction with the redesign of the parking lot, but acknowledges that the funding available for storm water management makes the parking lot redesign feasible at this time.

Recommendations: PRAB members favored Option #1 of the two options presented.

Regarding: Greater Baltimore Wilderness Coalition (GBWC)

The City of Greenbelt has been a member of the Baltimore-Washington Partners in Forest Stewardship (BWPFS) since June 23, 2011. As a BWPFS member, Public Works attends quarterly meetings participating and helping with all the initiatives of the BWPFS.

The BWPFS Steering Committee has agreed to join with other federal, state, local area governments, and nonprofit organizations to expand the area of stewardship, restoration and conservation of the region. The members of this larger area will be called the Greater Baltimore Wilderness Coalition (GBWC).

The mission of the GBWC is to improve the quality of life for residents and visitors of central Maryland by identifying, restoring, enhancing and protecting an interconnected network of lands and waters supporting healthy ecosystems and communities that benefit people and wildlife. The mission is no different than the BWPFS only on a larger scale.

The GBWC is similar to the BWPFS in how they share information and there is no agency resource commitment other than attending a quarterly meeting. BWPFS members are being asked to sign the GBWC Accord (Accord) since it is in harmony with the goals of the BWPFS. The Accord has been approved by 23 others organizations including Maryland National Capital Park and Planning and most recently by the City of Bowie.

Staff recommends that Council support the Greater Baltimore Wilderness Coalition Accord by signing the Accord. Staff has found the information sharing and networking for this initiative to be very valuable for staff development and the initiative is improving interconnected waterways, habitat and land throughout the region.



Greater Baltimore Wilderness Accord

This Accord is made and entered into by and among the members of the Greater Baltimore Wilderness Coalition (hereafter referred to as the **Baltimore Wilderness or BW**.) The Accord creates a voluntary network of local, state and federal agencies and independent organizations that share and support common goals.

Vision

Baltimore Wilderness envisions a future where:

- Accessible interconnected and healthy ecosystems contribute to economic vitality, resilience and quality of life for all of the region's residents and visitors;
- The region's working lands, watersheds, open spaces and natural communities are intentionally protected, restored, enhanced, and managed for ecological health; and
- Healthy and prosperous communities appreciate and support natural ecosystems, creating an enduring culture of conservation and stewardship.

Mission

To improve the quality of life for residents and visitors of central Maryland by identifying, restoring, enhancing and protecting an interconnected network of lands and waters supporting healthy ecosystems and communities that benefit people and wildlife.

To achieve this mission, Baltimore Wilderness will focus on four programmatic pillars:

- Resilience To improve the region's capacity to achieve lasting economic vitality, BW will seek to mitigate impacts of climate change including sea level rise, flooding, stronger coastal storms, warmer temperatures, and drought through a protected regional green infrastructure network that includes forests, wetlands, parks, rain gardens and urban tree canopy. This network will absorb rainfall, store water, reduce flooding and provide additional community benefits, such as cleaner air, space for recreation, and relief from urban heat.
- Biodiversity In this rapidly developing region wildlife habitat is continually fragmented or lost due to traditional infrastructure and development. Preserving valuable natural areas, such as forests, wetlands, vernal pools, and coastal environments provides access to food and shelter for wildlife, offers corridors for migration, and protects vulnerable, often at risk species.
- Equity As access to nature is unequally available across the region, BW seeks to connect the region's increasingly urbanized population with nature. Local and regional greenways, city parks, restored stream corridors, urban waterways and trees can reach even into heavily developed areas and provide connections with green and blue natural resources.
- Discovery and Engagement In a world that is increasingly urbanized and dominated by technology, environmental and outdoor education for

children and adults is even more important. BW must direct the attention of present and up-and-coming generations to the richness and value of the natural world so that we will collectively do better as its stewards.

Recitals

WHEREAS, the Greater Baltimore region's natural resource lands are permeated by intense urban development making protection and restoration of contiguous blocks of green infrastructure critical for the region's resilience to climate change, water and air quality and living resource services; and

WHEREAS, Federal, state and local agencies have a critical role in the protection, conservation, restoration and enhancement of unique and sensitive habitats and plant and animal communities; the maintenance and improvement of local soil, water and air quality; the reduction of greenhouse gases; and the provision of recreational and aesthetic amenities to the community; and

WHEREAS, we support the Chesapeake Bay Program and its signatory partners to meet the commitments of the New Chesapeake 2014 Watershed Agreement; and

WHEREAS, collaborative research and innovative technology improves natural resource management among participating organizations and the community;

WHEREAS, we recognize the value and mutual benefit of aligning governmental and private partner resources to achieve a common vision that engages participation of affected individuals.

NOW THEREFORE,

Each Member commits to the following:

- Fostering coordination of support for management and research to achieve stewardship objectives consistent with constraints of affected agencies or organizations;
- Improving communication among Coalition members and the public about shared goals and ideals for environmental stewardship;
- Meeting regularly to identify restoration, management or monitoring initiatives of mutual interest in targeted geographic areas;
- Maintaining and enhancing ecological, environmental and societal services provided by green infrastructure through management, restoration and conservation actions;
- Developing and implementing joint management strategies for green infrastructure when feasible, given available financial and staff resources and legal authority;
- Conducting outreach activities to improve awareness, and integrate public and private sensitivity to environmental issues; and
- Defining and adopting sustainability criteria to guide our strategies, evaluate the progress of the Coalition, and communicate benefits to members and the public.

IN FURTHERANCE OF THESE SHARED VALUES AND COMMITMENTS, it is mutually agreed and understood by and among the parties hereto that,

This Accord reflects a commitment among the parties to work together to achieve the vision and mission articulated herein. This Accord in no way obligates or restricts the activity of any party hereto in any way. No Member shall obligate, or purport to obligate, any other Member with respect to any matter. Other voluntary policies and practices are described in the Policies and Procedures document adopted by the Steering Committee.

CITY OF GREENBELT PROGRAM OPEN SPACE FY 2017 ANNUAL PROGRAM

Justification & Narrative Description of Projects

The following materials are intended to clarify the City of Greenbelt's submission for the FY 2017 Program Open Space (POS) Annual Program. The City's FY 2017 Annual Program includes two development projects and one acquisition projects. One of the development projects, *Community Center Facility Upgrades*, has received Board of Public Works approval but the City is requesting additional POS funding. The second development project, *Community Center Playground Renovation* is a new POS project.

Status of FY 2016 POS Annual Program & Encumbered Projects

The City's FY 2016 POS Annual Program submission consisted of two development project (Community Center Facility Upgrades and Buddy Attick Park Master Plan Improvements) and one acquisition project. The Board of Public Works has approved the Community Center Facility Upgrades Project and the Buddy Attick Park Master Plan Improvements Project. The City expects the Community Center Facility Upgrade Project to be completed in FY 2017. The City is currently working on designs for improvements to the parking lot at Buddy Attick Park, and anticipates this project moving forward to construction in FY 2017.

The acquisition project, *Greenbelt Parkland Acquisition*, remains on hold as no acquisition projects have presented themselves to the City. If an opportunity arises the City will revise its annual program to be more site specific.

The City has several additional projects that have received Board of Public Works approval including the following: Greenbelt Aquatic and Fitness Center Upgrades Phase III, Greenbelt Aquatic and Fitness Center Upgrades Phase II and Springhill Lake Center Expansion project. The Greenbelt Aquatic and Fitness Center Upgrades Phase III will be completed this fiscal year.

Justification for FY 2017 Projects

The City is strongly committed to protecting diminishing open space resources and providing quality recreational facility for its residents. The City's philosophy and policy commitment to this goal are set forth in the City's adopted goals action plan. This goals action plan includes an open space component, which defines a broad goal "to protect and increase Greenbelt's open space," and then spells out 12 objectives to achieve this goal.

The following is a brief description of and justification for the City's three proposed projects:

PROGRAM OPEN SPACE FY 2017 ANNUAL PROGRAM

Justification & Narrative Description of Projects (continued)

Community Center Facility Upgrades (D-G1): The Greenbelt Community Center is a 55,000 square foot facility which was renovated in 1996. The original part of the building was built in 1937, and holds several historic designations. The facility is home to recreation classes, camps, senior daycare, children's daycare, special events and community meeting space. The facility houses City offices, resident studio artists, dance studio, GATE studio and gymnasium with stage. The facilities meeting space is used by various religious and community organizations. Currently a number of the facilities HVAC system components have failed resulting in deficiencies in performance and/or complete lack of climate control.

HVAC system improvements include; enhancements to system air handling and duct work in various areas of the building, zoning the system in some areas of the facility, replacement of fan coil units in the majority of rooms and other enhancements which will result in a more energy efficient and effective HVAC system.

This project is consistent with the State's 2009 planning visions. The project also supports the six goals that were development by the State of Maryland including providing high quality accessible recreational opportunities to the public and supporting investment in local recreation facilities.

The City has awarded a contract for construction services and expects installation of the new HVAC systems to get underway soon.

Community Center Playground Renovation (D-G2): The City proposes to renovate an existing playground that is located in the historic core of the community near several recreation facilities including a community center, youth center, aquatic center, ball fields and library, as well as numerous homes. The playground serves children ages 2-5. Additionally the playground will be designed to be ADA and SPSC compliant.

The existing playground has equipment that is 25 years old or older and is no longer compliant with current safety guidelines. Additionally some of the equipment is directly under large mature trees, which creates a potential hazard from falling limbs and is not ideal for the health of the trees.

The project is consistent with the 2009 Maryland Planning Visions and the Prince George's County Park and Recreation Goals. The project will involve public participation in the planning and design of improvements. The project supports the City's commitment to resource conservation, land stewardship and the provision of high quality sustainable recreational/environmental resources.

Greenbelt Parkland Acquisition (A-G1): This project proposes the acquisition of unspecified acres of undeveloped land for use as passive and/or active parkland. While

the City is not able to identify a specific parcel of land for acquisition at this time, by including this project in its annual program it will be in a better position to react if a parcel of land becomes available that the City has identified as having open space/recreation value. This project is consistent with both the City's goal to protect open space as well as the State's 2009 Planning Visions that advocate environmental protection, resource conservation and local stewardship efforts.
