Me. McLaughlin,

Thank you for your reply. I profusely apologize if one of our Guard Force members was (or was perceived to be) discourteous to one of our neighbors.

The facility is a US Government Facility and has been designated as a Federal Security Level 2 facility, in accordance with the Interagency Security Committee Risk Management Process for Federal Facilities and the Contract Requirements flowed down in Technical Directive 010. A primary concern is for the safety of the Federal Employees, Contract Employees and official visitors to the facility. We also are concerned for the safety of the neighborhood residents. When the buildings were vacant, the parking lots were a convenient place for exercise, shortcuts to the Greenway Center and the Post Office, or just enjoying the pond. Now the lots will be full, with traffic entering and leaving all day and into the night. That level of convenience and safety will be drastically reduced.

The building functionality has no public offerings, nor are they open to the public. Any public interface with the Census Bureau will occur at the Census Bureau Headquarters in Suitland, Maryland. Or, perhaps, through your office. Where I am going with this chain of thought is; that there is no official use of the facility or its parking lots for the general public. In an age where some people (albeit a very small number) would do harm to a Federal Facility or its employees, we must

be mindful of strangers on our grounds as our employees exit the buildings to the parking lots - especially at night.

As for the cited encounter, there are no guards with firearms at this time. Our Guard Force is not authorized to be armed. Arming of the Guard Force will occur in January when Census Bureau personnel occupy the building, as this is a requirement stated by the Census Bureau. I will discuss this encounter with our Guard Force. I certainly hope we are courteous with our neighbors, but we have had several people on the grounds who were not exercising nor enjoying the splendor of the wetland. The buildings sat vacant for a long time and the parking lot areas behind the buildings (in particular the 3 story building) provides visual cover from the streets. We have engaged people in their parked vehicles, who declined to state their business in the parking lot, and have asked them to leave. We have asked the Greenbelt Police to increase their patrols in our parking lots to discourage any further nefarious activities that may have taken place during the vacancy period.

We look forward to meeting with you to discuss these concerns. The occupation of these buildings is a good thing for the community, and for the performance of the 2020 Decennial Census. The Decennial Census surveys are mandated by the U.S. Constitution, and contribute the services provided to the nation as well as the Congressional Districting process.

I am proud to be a contributor to the 2020 Decennial Census and I am sure that the Greenbelt community will be as well.

In that vein we would like to meet with the Greenway Center merchants, let them know about the large population moving in and perhaps obtain some flyers or other literature about their offerings.

Mr. Howe – Thank you for reaching out to our Police Department about your company's expansion in Greenbelt. We are thrilled to see those two buildings put to use, but have a concern about the parking impact. As I understand it, you expect 800 people to work there, but there are only 400 parking spaces. Will all 800 be there at the same time/work the same shift? Or will there be multiple shifts? Are there any plans/thoughts on how to mitigate/address the parking need if everyone is there at the same time? Do you expect many of your employees to use mass transit or carpool? While there is parking on Ora Glen Drive, it cannot accommodate the potential overflow.

Capt. Moreland,

We have ~ 120 people assigned to 7615 Ora Glen Dr. now and that will grow to about 300 over the next few months As for 7601 Ora Glen Dr. we are looking to occupy the 3^{rd} floor with 200 people in January, beginning on or around the 10^{th} . It will take most of the month to get all 200 in there and settled. The 2^{nd} floor is the same beginning on 10 Feb and the 1^{st} floor will be 100 people beginning on 10 April. As we stated, our end point should be 800 people, and we should peek in May or June.

Our Guard force will arm in December so as to be fully deployed by 10 Jan.

We should be here through 2021 with 2 one year options, which will take us through 2023
